Conducted a qualitative narrative dissertation on the experiences of homeless romantic couples that met and reside at a temporary living facility. Conducted in-person, dyadic interviews of six couples about their experiences of being in a romantic relationship while being homeless. Transcribed each interview and analyzed data through the lens of Relational Cultural Theory.
