# **CURRENT POSITION**

Dean, College of Education and Human Development, Texas A&M University San Antonio. - Supervises the administrative staff and department chairs in the conduct of the routine business of the college.
- Maintains programs for effective academic advising, degree planning, and maintenance of student records. Certifies students for graduation. Supports the university's student-recruiting programs and develops college-level student-recruiting programs serving both traditional and non-traditional students.
- Supervises the development of personnel policies and procedures within the college and ensures compliance and consistency with university-wide faculty personnel policies and procedures.
- Identifies faculty and staff personnel needs and demonstrates a commitment to the recruitment, advancement, and retention of a diverse faculty and staff.
- Develops and manages the budget for the college.
- Develops a vision for the college that is consistent with the university's mission as given in the strategic plan and develops plans and priorities to achieve the mission including those related to the accreditation process.
- Provides support to student organizations and activities. Assists in fund-raising activities for the college and assists department chairs with similar activities.
