**Catalog Course Description:** This course introduces the nature and structure of the US and Texas legal systems; the basic principles of legal reasoning; and laws having a substantial impact on business including contracts, business organizations, and the Uniform Commercial Code.

Prerequisites: ENGL 1301 & ENGL 1302

Student Learning Outcomes: Upon completion of this course, you should be able to:

- Understand Business Entities including the advantages and disadvantages of each.
- Identify the difference between Intentional Torts and Negligence.
- Analyze if a valid, enforceable Contract exists.

• Evaluate case problems using Legal Reasoning. Grading Policy:

- 12 Simulations: Most weeks, students will complte a simulation (also called an ABA) through McGraw Hill Connect. Simulations will be due at 11:59pm on the Sundays (except Simulation 12) noted on the schedule below. You will have two attempts to complete each simulation. Late submissions will NOT be accepted without a documented medical emergency note. To be able to complete a simulation after the due date, you must email the professor to be granted access. (Yes, that's annoying, but there are limited settings on Connect for this sort of thing.) Simulations completed in accordance with the late policy will receive half credit. Your lowest simulation grade will be dropped. The average of your simulations will be 25% of your course grade.
- **Discussions:** There are 12 discussion topics assigned on Blackboard (the lowest score will be dropped) that are available on Monday and end on Sunday 11:59pm CST. You must submit your main response by Wednesday, and respond "at a minimum" to two others in class on two separate days. Your responses must be substantial contributions to the assignment, supported by sources (statutes, cases, articles). Use the university online library system to locate scholarly sources.
- **3 Exams**: This course will have three exams (including a comprehensive Final Exam). Exams will consist of case problem style questions. Exams will be completed in class. Exams 1 & 2 will be 20% of your course grade and the Final will be 25%.
- Extra Credit: This is NO extra credit available in this course. [Not even if you email me at the end of the semester asking.]
- Academic Dishonesty: Any assignment found to contain plagiarized material or be the result of any academic dishonesty will receive the grade of zero. In addition, two instances of academic dishonesty will result in the grade of F being assigned for the course.

### Make up and Late Assignment/exam policy:

Simulations: Late submissions will be accepted for five additional days (i.e. until the following Wednesday). To be able to complete a simulation after the due date, you must email the professor to be granted access.

Exams: You must provide prior notice if you miss an exam in a non-emergency situation. Failure to do this will result in a 20-point reduction in your exam grade. Any make-up exams should be taken within one week of the schedule exam date. Taking the Final Exam late may result in an incomplete for the course.

# Definition Of a Credit Hour:

"A credit hour is an amount of work that reasonably approximates: not less than one hour of classroom or direct faculty instruction and a minimum of two hours out of class student work each week for approximately 15 weeks for one semester, or the equivalent amount of work over a different amount of time; at least an equivalent amount of work as outlined in the item above for other academic activities as established by the institution including laboratory work, internships, practicum, studio work, and other academic work leading to the award of credit hours. (This information is in accord with federal regulations regarding the definition and assignment of credit hours under section 600.0 and 600.24(f) of the Higher Education Opportunity Act.)

"A credit hour represents a unit of measure of instruction consisting of 60 minutes, of which 50 minutes must be direct instruction over a 15-week period in a semester system. Academic administrative units are responsible for ensuring that credit hours are awarded only for work that meets this requirement. (This is in accord with The Texas Higher Education Coordinating Board definition.) Transfer credits will be evaluating for equivalency to this requirement. ### Therefore, this course requires 3 hours of class time plus a minimum of 6 hours of homework per week.

# **IMPORTANT POLICIES AND RESOURCES**

<u>Artificial Intelligence (AI) Policy</u>: This course requires that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

<u>AACSB Assessment</u>: The College of Business has received AACSB accreditation. Students will be assessed on program level outcomes based on course outcomes from various courses. The materials from this course may be used for assessing such program level outcomes, and hence students must follow the necessary rigor to ensure mastery and retention of the above course outcomes.

<u>Class Conduct and Civility Code</u>: Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions in class and online, including the following:

- 1. Attendance may be taken at the beginning or the end of the class.

- 6. For any questions about the exams and assignments, a student should contact the instructor, well in advance of the day they are due, so the instructor may have enough time to provide feedback.
- 7. All communications will be via e-mail communications to the Texas A&M University e-mail account, and students are expected to use their school provided email account. The instructor will reply to a student e-mail messages and voice messages within 2 business days (Monday-Friday).
- 8. All assignment submissions must be uploaded to Blackboard by the due date and time. Submission window may close or marked late, even if late by one second.

Anyone violating these policies may be subject to disciplinary actions.

<u>Class Attendance and Participation</u>: A vital part of every student's education is regular attendance of class meetings. Any absences tend to lower the quality of a student's work, and frequent or persistent absences may result in a failing grade. Students are responsible for the materials covered in class. The course covers a lot of material and most students find at least some parts of it difficult. Class participation is highly encouraged as it makes the class more interesting and enhances the learning experience. Students are strongly encouraged to ask questions, participate in class discussions and problem solving, and visit/contact the instructor during office hours in case of questions or concerns. Good attendance and participation will be rewarded when final grades are assigned.

The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important, and may vary considerably based on student background. However, a minimum of two hours of work outside the class is expected for every one hour of class period per week. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.

<u>Financial Aid and Verification of Attendance</u>: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

If you wish to drop the class, you must submit the necessary paperwork to the proper authority. Students dropping a course are subject to all conditions listed in the university catalog.
