### **COURSE DESCRIPTION & MATERIALS:**

**Catalog Description:** In-depth study & applications of polynomial, rational, radical, exponential & logarithmic functions, & systems of equations using matrices. Additional topics such as sequences, series, probability, & conics may be included. This course meets the standards for the Mathematics category of courses under the core curriculum. This course meets the standards for the Mathematics category of courses under the core curriculum.

**Prerequisite:** Evidence of math equivalent to High School Algebra II ('C' or above) or placement.

**Required Textbook**: Pre-Calculus Essentials by Robert F. Blitzer, 6<sup>th</sup> Ed., with MyMathLab, Pearson Publishing, 2018, ISBN 9780134469164. (E-book package as part of course registration). Note: Students can purchase a loose-leaf version of text for a low cost if desired (check bookstore). The course ID is accessible through Blackboard. You do not need to buy a physical textbook, you will have a copy of the electronic textbook when you buy MyMath Lab. More information will be given in class.

**Calculator Policy:** Scientific and graphing calculators are permitted but they must not be programable.

NOTE: This class meets 2 times a week. Aside from the 2½ hours that you spend in class each week, you should devote at least another 4 to 6 hours to studying on your own: reading the book

& my lecture notes, working out homework assignments & solving extra related problems for practice, etc. You are responsible for any & all materials/topics discussed in this class.

**Student Learning Outcomes**: MATH 2312 helps students develop critical thinking, communication, and empirical and quantitative skills by focusing on student understanding of key mathematical concepts required for calculus readiness to include recognizing, identifying, solving, analyzing and explaining appropriately model applicable real -world situations. Upon completion of this course, students will:

- 1. Demonstrate understanding and knowledge of properties of functions from graphical, tabular, symbolic, or verbal representations.
- 2. Identify and apply appropriate strategies for solving equations involving algebraic, transcendental, and trigonometric functions.
- 3. Interpret and apply graphing techniques to algebraic and transcendental functions.
- 4. Compute and apply the values of trigonometric functions for key angles in all quadrants of the unit circle measured in both degrees and radians.
- 5. Prove and apply trigonometric identities.
- 6. Interpret and solve applications related to right and oblique triangles.

If you have experienced any form of sex- or gender- based discrimination or harassment, including sexual assault, sexual harassment, domestic or dating violence, or stalking, know that help and support are available. A&M-San Antonio has staff members trained to support survivors in navigating campus life, accessing health and counseling services, providing academic and housing accommodations, and more. Students' Rights and Responsibilities The purpose of the following statement is to enumerate the essential provisions for the student freedom and responsibility to learn at Texas A&M University-San Antonio. All students are required to follow all policies and regulations as set forth by The Texas A&M University System. This includes the <u>A&M-San Antonio Student Code of Conduct.</u>

Students' Rights

- 1. A student shall have the right to participate in a free exchange of ideas, and there shall be no university rule or procedure that in any way abridges the rights of freedom of speech, expression, petition and peaceful assembly as set forth in the U.S. Constitution.
- 2. Each student shall have the right to participate in all areas and activities of the university, free from any form of discrimination, including harassment, on the basis of race, color, national or ethnic origin, religion, sex, disability, age, sexual orientation, genetic information, veteran status, gender identity, or gender expression in accordance with applicable federal and state laws.
- 3. A student has the right to personal privacy except as otherwise provided by law, and this will be observed by students and University authorities alike.
- 4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

- 1. A student has the responsibility to respect the rights and property of others, including other students, the faculty and the administration.
- 2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, Student Code of Conduct, on our website, University Catalog and students must comply with them and the laws of the land.
- 3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire university community.
- 4. A student has the responsibility to recognize the University's obligation to provide an environment for learning.
- 5. A student has the responsibility to check their university email for any updates or official university notification.
- 6. We expect that students will behave in a manner that is dignified, respectful, and courteous to all people, regardless of sex, ethnic/racial origin, religious background, sexual orientation or disability. Behaviors that infringe on the rights of another individual will not be tolerated.

Writing, Language, and Digital Composing Center The Writing, Language, and Digital Composing Center supports graduate and undergraduate students in all three colleges as well as faculty and staff.
