Course Objective: This course is designed to prepare students to (a) read, understand, and evaluate research in the field of kinesiology and (b) construct a written research proposal. This course explores the concepts and procedures necessary for designing, conducting, and analyzing research in Kinesiology. The course will focus on the steps involved in the synthesis of a research project, including literature review, design, data collection and analysis.

Student Learner Outcomes: Upon completion of this course, each student will be able to:

- 1. Understand the difference between quantitative and qualitative research, the methods used to obtain these types of data, and appropriate study designs for these types of research.
- 2. Understand the need and importance of research in the field of kinesiology.
- 3. Critically analyze research in an area of interest.
- 4. Demonstrate knowledge of ethics in research.
- 5. Search and acquire research articles relevant to a topic of interest.
- 6. Have an applied understanding of basic statistical techniques.
- 7. Know the steps needed to acquire approval from an IRB board for research using human participants.
- 8. Design a research project worthy of graduate research project or thesis material.

Class Attendance:

A vital part of every student's education is regular attendance of class meetings. Any absences tend to lower the quality of a student's work in a course, and frequent or persistent absences may preclude a passing grade or cause a student to be dropped from one or more courses upon the request of a faculty member to the Provost and Vice President for Academic Affairs.

- Quizzes, assignments, and other work related to weekly topics will be completed inside and/or outside of class. In-class quizzes, assignments, and other work missed because of absence will *not* be made up.
