Catalog Course Description: This course builds upon the concepts learned in ACCT 3303 Intermediate Accounting II providing an in-depth understanding of the source and use of authoritative accounting pronouncements. The course provides an exhaustive study of the accounting for liabilities and owners' Equity. Special emphasis is given to the accounting principles for long-term liabilities, stockholders' equity, income taxes, pensions, leases, and statement of cash flows. Students will acquire practice in using the concept of the time value of money to determine the value of leases and long-term liabilities.

**Course Objectives:** The objective of the course is to provide a basic understanding of financial accounting. Especially, this course focuses on understanding accounting procedures for firms' investing and financing activities.

**Prerequisites:** Admitted into the College of Business, grade of "C" or better in ACCT 3303.

### **Student Learning Outcomes:**

After successful completion of the course, the student will:

- (a) describe the function and primary focus of financial accounting, explain factors that encourage high-quality financial reporting, and describe the four basic assumptions underlying GAAP;
- (b) demonstrate the way to identify and account for investments classified for reporting purposes as held-to-maturity;
- (c) explain the adjustments made in the equity method when the fair value of the net assets underlying an investment exceeds their book value at acquisition.;
- (d) describe the components of shareholders' equity and explain how they are reported in a statement of shareholders' equity;
- (e) explain the usefulness of the statement of cash flows and prepare a statement of cash flows

with the aid of a spreadsheet or T-accounts;

(f) understand and apply accounting principles and procedures involving hedge accounting;

**AACSB Assessment:** The College of Business is in the process of applying for AACSB accreditation. - **Time Expectation for coursework:** You are expected to spend 3-6 hours per week for the course. Based on the background, some student may require more time. Time spent may be longer when assignment/exams are due.

### Course Requirements every student must fulfill in order to succeed in course:

- 1. Students should check the Course Calendar, Announcements, and Emails on a regular basis.
- 2. Students should keep current with all course assignments, quizzes, and examinations.
- 3. If the course uses remote proctoring for exams, students must schedule their exam early in the semester.

**Grading Policy:** The final course grade will be based on your performance on the quizzes, exams, assignments and attendance using the following weights:

The final letter grades will be assigned as follows: Above  $90\% \Rightarrow A$ ;  $80 - 89.99\% \Rightarrow B$ ;  $70 - 79.99\% \Rightarrow C$ ;  $60 - 69.99\% \Rightarrow D$ ; Below  $60\% \Rightarrow F$ .

This course has a requirement of a grade of C as a minimal grade for satisfactory completion of this course.

The instructor reserves the right to adjust the student's final grade based on the overall performance.

Examinations: There will be two mandatory mid-term exams and a mandatory final exam (as per university schedule). The exams/quizzes will consist of conceptual multiple-choice questions, problem solving questions, and short essay questions. The exam/quiz materials will come from lecture notes, the text, and class discussions. Questions will emphasize understanding and applications of concepts and topics covered in class. Missing an exam will result in a grade of zero for that exam and may result in a fail grade in the course.

**Proctored Exams:** Examinations in this class may/will be administered using secure online testing services. Details regarding proctored test sign up and administration will be provided at least 2 weeks prior to the exam.

**Assignments:** Problem solving homework will be assigned for the most of chapters. The purpose of homework is to apply the information learned during class. Each problem solving homework assignment will be available for two weeks to complete it. Students can refer the homework schedule to find out exact dates for each assignment.

**Experiential Learning Assignment:** Students will find the Accounting Standards updates from Financial Accounting Standards Boards (FASB) website and write a paper regarding the expected effect of the Accounting rule changes.

Make up and Late Assignment/exam/quiz policy: As a general rule, make-ups or late submissions will NOT be offered or accepted for any missed assignments/exams/quizzes. Late submissions or make-ups may be accepted/administered only in extra-ordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation either before or within a few days of the missed assignment/quiz/exam.

Generative Artificial Intelligence (AI): ACCT3304 assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Course Drop Policy: You may drop the course on or before Nov. 11, 2024 with an automatic grade of W. If you wish to drop the class after that date, you will receive either W (if you have satisfactory record so far) or F. The last date to drop a course, or withdraw from the University is Nov. 19, 2024. If you wish to drop the class, you must submit the necessary paperwork to the proper authority.

The course covers a lot of material and most students find at least some parts of it difficult. The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.
