# **Course Description**

This course provides a solid background in ecology and introduces the student to the scientific study of organisms and their environment. We will address the basic abiotic and biotic components involved in the function and evolution of ecosystems, different ecological models, and the mechanisms that drive ecosystem changes through time. The course will incorporate the classic concepts of ecology and will introduce the students into current theoretical and applied aspects of ecology, from a global scale to the organismal level.

# **Course Objectives**

- 1. Develop an appreciation of past and modern scope of scientific inquiry in the field of Ecology, through Laboratory exercises.
- 2. Learn how to formulate ecological questions, followed by a hypothesis, objectives, and methods of inquiry to test the proposed hypotheses.
- 3. Understand how scientific studies in ecology are conducted including techniques, methods and the equipment used to address different ecological questions.
- 4. Become familiar with data collecting protocols, sample analysis in the laboratory, and statistical data analysis using Microsoft Excel among other software.
- 5. Learn how to record field observation and experimental results in a laboratory notebook
- 6. Learn how to organize and present results in your laboratory notebook using tables and figures
- 7. Learn how to describe and interpret the results presented in tables and figures

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. #### No Use of Generative AI Permitted

Biol 3407 assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Article III: Conduct Rules and Regulations. Texas A&M University-San Antonio faculty has the discretion to impose grade penalties as deemed necessary.
