# **Course Description**

This course provides a solid background in ecology and introduces the student to the scientific study of organisms and their environment. We will address the basic abiotic and biotic components involved in the function and evolution of ecosystems, different ecological models, and the mechanisms that drive ecosystem changes through time. The course will incorporate the classic concepts in ecology and introduce the students to current theoretical and applied aspects of ecology, from a global scale to the organismal level.

# **Course Objectives**

- 1. Develop an appreciation of the past and modern scope of scientific inquiry in Ecology, through lectures and assignments.
- 2. Understand the mechanisms behind the interaction between organisms (from bacteria to plants and animals) and their environment.
- 3. Understand how scientists conduct studies in ecology, including techniques, methods, and equipment used to address different ecological questions.
- 4. Learn about the many theoretical and applied aspects of ecology globally, and in Southern Texas, particularly Bexar County.
- 5. Understand the importance of ecology as a tool to study current environmental issues.
- 6. Understand the effects of ecological processes on our lives and all living systems.

- I will provide instructions and you will submit the news article in a folder titled Ecology News. You need to write a summary of what the article is about and include the link. <u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
