Course Description and Prerequisites:

Scientific fields advance through scientific exchange and discussion, which gives rise to the generation of new ideas, new hypotheses, new questions and new methods to address them. In this course, we will focus on both oral and written communication skills, with commonly used tools to communicate science. Compilation of current literature pertaining to topics in zoology will be critically evaluated. Students will enhance their ability to conduct literature searches, review, understand, discuss and critique articles from the primary literature. Students in this course will engage in Lesson geared towards improving scientific writing and discussion that is led by students. Students are expected to come prepared to each class by reading the assigned article(s) to be able to participate in discussions. Active participation is required for all lessons and discussions and will serve as major component of your grade. As this is a writing intensive course, **to pass this course, you must pass both written and oral components.**

Prerequisite: BIOL 3402 and ENGL 2311 or ENGL 1302.

Learning Objectives:

- 1) Practice oral and written scientific communication.
- 2) Critically evaluate and review a research proposal.
- 3) Discuss and present topics in zoology.

Required Textbook and Course Material:

There are no required textbooks. Course materials and guidelines will be posted on the learning management system Blackboard for course administration and assessment.

Attendance Policy:

Synchronous attendance is mandatory, and points will be assessed every class period. Discuss unavoidable absences with Dr. Borda prior to missing class.

COURSE POLICIES

Course Expectations:

Personal and academic integrity, to be open to new ideas, and to share in a community where individuals from diverse backgrounds and cultures help one another grow intellectually, socially, and personally is expected at all times throughout the course. The faculty and staff of TAMUSA are here to help; however, students must take responsibility for their own learning. Students should strive for a high level of academic performance and to be responsible, respectful, contributing citizens within the university and in outside communities. Above all, students should develop a love of learning that will last a lifetime, along with a life-long interest in maintaining emotional and physical wellness.

Active Participation:

Students are expected to actively participate during class. It is recognized that students learn in a diversity of ways, thus diverse teaching strategies will be implemented as part of the course (e.g., active discussion, reading, writing, individual reflection, etc.). There are multiple ways to demonstrate active learning engagement in this course and the intention is for students to strive beyond their preferred ways of learning and comfort zones, as dissonance can promote new learning. Students are highly encouraged to contribute thoughtful comments and questions, as well as to listen carefully to your peers' contributions and respectfully respond to others' comments. The success of mutual learning depends upon preparation and active participation in all aspects of the course.

Grading:

If you believe an error was made in grading, please do not hesitate to bring it to my attention as soon as possible. If you find yourself struggling with this course, please talk to Dr. Borda as soon as possible and **do not wait until the end of the semester.** You are always welcome to make an appointment to discuss your concerns. To be successful in this course you are expected to complete all assignments on time and be an active participant.

Lessons:

There will be 5 Lessons designed to provide guidance for course assignments that will be required for assess course performance. Some Lessons have out-of-class assignments associated with them (see below). However, Lessons must be attended (or reviewed) to be eligible to submit the associated work assignment to reflect your learning of the Lesson topic. These Lessons cannot be made up.

Resume/CV and Personal Statement:

We will work together to write a resume and personal statement that you can use after you graduate and fill out a practice application for a job or graduate school.

Discussions:

You will be responsible for leading one discussion based on one journal article you have selected. You will submit your first-choice article and two backup articles as pdfs, so that a ready alternate is available in cases of inappropriate first choices. The article will be posted on the Discussion Board a week prior to the discussion date to allow classmates one week to read and prepare. The Discussion Lead will lead the discussion for 1/3 of the class period (~15 min). The order of discussions will be randomly assigned using a random number generator. To encourage in-class Discussion, 50-point bonus will be awarded to the Discussion Lead.

Discussions (Discussion Board):

To accommodate instructor travel, remaining Discussions will take place on the Discussion Board. The Discussion Lead will prepare a 5-minute video presentation recorded on Zoom to summarize the article and provide points to lead the discussion on the Discussion Board. Students are required to post questions and participated in all Discussions to earn participation points. Discussion participation should be completed no later than November 25.

Preparation for the Discussion:

You will submit brief summaries of each of the articles with questions and comments prior to discussion. This summary will both prepare you for the discussion and provide evidence of your preparation. If there are terms or other concepts you do not understand in the paper, be sure to look them up and include them in the summary, but questions make the best preparation for discussion and will increase your performance score.

Your summary should include two questions or thoughtful comments you had about each article. A file containing your summary must be submitted prior to the discussion. You will be responsible for submitting 10 summaries and 10 sets of questions to earn full credit.

Assessment of Contribution to the Discussion:

In recognition of learning by listening to the discussion, and providing an audience, you will earn 10 points for each in class participation (there will be 3 in class discussions over 4 class periods) resulting in a total of 100 points. Another 75 points will be earned by thoughtfully participating 3 times during the discussions. This participation can include asking a good question or making a supportive or critical comment about the paper being discussed or mentioning outside material that adds to the discussion. A checklist will be kept for each inclass period to keep track of your participation effort.

Journal Article Critiques:

You will write three papers that critically analyze scientific journal articles. Guidance will be provided in the planned Lessons (see schedule).

<u>Financial Aid and Verification of Attendance</u>: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
