Course Description

This course is designed to expose students to a wide range of topics, ideas, and perspectives through a series of engaging talks and presentations. In this seminar class, students will have the unique opportunity to broaden their horizons, challenge their preconceptions, and cultivate critical thinking skills by attending presentations and lunch discussions with guest lecturers from diverse academic backgrounds.

Course Objectives

- 1. Exposure to Diversity: Gain exposure to broad topics, industries, and intellectual fields through weekly guest speakers.
- 2. Critical Thinking: Develop critical thinking and analytical skills by engaging with complex and multidisciplinary ideas presented by experts.
- 3. Interdisciplinary Exploration: Foster an appreciation for interdisciplinary connections and the interplay between various fields of knowledge.
- 4. Networking: Build connections with guest speakers and fellow students motivated by intellectual curiosity.
- 5. Communication Skills: Improve listening skills, and ability to engage in meaningful discussions during Q&A sessions.

Course Policies

Attendance: You are required to attend **every class**.

Participation: I expect that you will review the course material for the week and review material from previous lectures, so you come to class ready with questions.

Course Changes: This course syllabus and lecture schedule are subject to change at any time; however, I will notify any changes through announcements in Blackboard or during seminar.

Late assignments submission: I will deduct 10% of the assignment's possible points for each day after the due date.

Course Evaluation

Attendance ($12 \times 10 = 120 \text{ points}$): Attendance and participation is vital for your engagement and learning experience. You are required to attend all 12 scheduled speakers, earning you 120 points. There will be a sign-in sheet.

Introduction of Speaker (1 x 50 = 50 points): You will introduce one of our guest speakers during the series. The date will be randomly assigned to you. This exercise will enhance your public speaking skills and is worth 50 points.

Seminar Summaries ($12 \times 10 = 120 \text{ points}$): You are expected to write and submit a one-page summary of each speaker's presentation to demonstrate your comprehension and engagement with the material presented. Summaries will be submitted via Blackboard no later than 11:59 pm on the Friday of the following Seminar. You will write an essay for at least 12 seminars

Essay on article from speaker ($10 \times 10 = 100 \text{ points}$): You are expected to write and submit a one-page essay based on a peer-reviewed publication provided by the speaker a week before the presentation. The publication will be used to generate discussion during lunch. You will write an essay for at least 10 seminars. Essays will be submitted via Blackboard no later than 11:59 pm on the Thursday before the Seminar.

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. The faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending during the semester may also need to return a portion of their federal aid.

<u>The Six-Drop Rule:</u> Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
