Catalog Description and Prerequisites:

1308. Introduction to Life Sciences I. 3(3-0)

This course is designed for non-science majors and examines the basis of biology in the modern world and explores biology as a science - a data-driven process of gaining new knowledge – as well as the impact of biological science on society. Topics in this course include the study of life at the cellular level, investigating cellular structures, chemical processes, cell metabolism, cell division, gene expression and introducing patterns of inheritance. Includes experimental hands-on exercises. This course meets the standards for the Life and Physical Sciences category of courses under the core curriculum.

Learning objectives

Students will be able to have a strong grasp of the scientific method – specifically to:

- Ask scientific questions of their world
- Demonstrate the ability to read and understand scientific literature written for the educated lay reader
- Critique and analyze claims of others in a scientific context
- Construct reasonable hypotheses
- Formulate and defend alternative explanations and models on the basis of evidence
- Communicate effectively in oral and written forms
- Demonstrate awareness of specific technology that is used to carry out biological investigations
- Use computers for data analysis, literature searches and retrieval of data from reliable databases

Students will be able to understand the science of biology, both its past and present impacts on society by being able to:

- Analyze how progress in biology depends heavily on the political, social, economic and cultural influences occurring within a society at any given time
- Discuss historical changes in biological theories over time
- Recognize the integration of mathematics, physics, chemistry, and geology into the study of biology
- Understand the impact of science and technology on the global society
- Discuss and identify ethical issues that new technology raises
- Demonstrate the application of biological concepts to:
 - Personal issues
 - o Society
 - Economics
 - Technology
 - Ethical issues

Course Content

ASSIGNMENTS & QUIZZES = 40% of course grade

- Quizzes (10%): There will be a 10-question multiple-choice quiz at the beginning of the second class day each week (unless it is an exam day). This is done to encourage you to review the material from the previous classes regularly rather than cramming the night before each test. You will only have 10 minutes to take it once it has been handed out. Answers to these quizzes will marked via iClicker. There is no need to write on the quiz, as answers will directly be uploaded to iClicker Cloud and directly graded (can depend if answers are multiple choice). If you arrive late to class, you will have less time to take it or might miss the quiz altogether.
 - <u>The lowest quiz (1) will be dropped.</u>
- Virtual Labs (10%): The Connect software provided as part of your e-textbook have a variety of simulated lab activities intended to recreate assignments that would be done in a lab section. These may take between 10 and 30 minutes depending on how quickly you follow the instructions. A number of these virtual labs will be assigned with each unit to

assist with learning the concepts from those chapters. Each lab is a guaranteed 100% as long as it is completed on time and you have unlimited attempts before the due date.

- The lowest virtual lab (1) will be dropped.
- These assignments are <u>due by 11:59pm the Sunday following the exam they are</u> <u>related to</u>. I do not grant extensions on these since you will have several weeks to complete them.
- Activities (20%): Throughout the course of the semester, you will have some "hands-on" experiments or activities. These will be handouts provided for you in class, as well as posted in Blackboard so they can still be completed even if you are absent the day they are assigned. Due dates will be given with each assignment.
 - Activities can be submitted either in-person or on Blackboard, as long as they are submitted by their due dates.

EXAMS = 60% of course grade

- **4 Exams**: There will be 4 exams this semester, consisting of 45-50 multiple-choice and short-answer questions. Exams will be completed in-person and must be done within the class period. The fourth exam will serve as the final exam, but will mainly cover material from the last unit. However, it will include some general concept questions about material that has shown up all semester just to make sure you learned the basic concepts anyone who has taken a Bio 1 class should know.
 - There will be bonus questions on each exam for up to 6 extra points.

Dos & Do Nots

- Do come to class regularly and on time it affects your grade, not because of points assessed, but because of understanding the material.
- Do take notes on the print outs of my lectures
- Do ask questions in class
- Do seek out help from me and your peers
- Do NOT have your cell phone out during class unless asked to do so.
- Do NOT check social media sites on your laptop during my lecture feigning that you are taking notes
- Do NOT come in late or miss class and ask me to be caught up
- Do NOT leave early without talking to me prior to class beginning

Grade Breakdown:

- A = 90-100% (900-1000)
- B = 80-90% (800-899)
- C = 70-80% (700-799)
- D = 60-70% (600-699)
- F = < 60% (0-599)

I may consider rounding up an 89.5%, but not an 89.49% or less. Same for 79.5%, 69.5%, etc. You will be given bonus questions and have the lowest quiz dropped, so do not ask me to round up your grade at the end of the semester. If you are concerned you may finish close to the edge of a grade, talk to me during office hours sooner so you feel confident making the highest grade you can before the last minute.

POLICIES:

Please do not hesitate to ask questions in class. I am happy to clarify things and answer additional/related questions on a subject. If we are pressed for time, I may ask you to save a question or story until after class, but I firmly believe there is no such thing as a stupid question and will do my best to answer what you ask.

Makeups/Absences:

I will take attendance during every class period via questions submitted with iClicker, even though it is not calculated as part of the grade. If you have to miss a class, it is your responsibility to look at the lecture Powerpoints and keep up-to-date on what is due. Each student is responsible for informing their teacher about situations for excused absence as soon as they know it is happening. Students are also responsible for any material missed while absent, knowing what is due, and making it up in a timely manner if necessary. Powerpoints will be available on Blackboard, so students have access to the material from lecture.

- You may make up a quiz or an exam_only if:
 - you contact me within <u>one</u> day (24 hours) of the scheduled exam
 - your absence is one approved by TAMUSA policies (illness, death in the family, other immediate-family emergencies). Documentation will be required.
 - <u>Again if I do not hear from you within 24 hours of the scheduled exam, you have forfeited the right to make up the exam.</u>
 - <u>Students must complete make up quizzes or exams no later than 1 week after</u> <u>they've occurred</u>

<u>Late Work:</u>

Late work will be accepted with point deductions within a limited time period.

- Work submitted within 1 week of the due date will have a 10% point deduction.
- Work submitted more than 1 week after the due date will have another 10% point deduction for each week it is late. (Ex. 3 weeks late = -30%)
- Work that is 10 or more weeks late will not be accepted
- No work, other than the final exam, will be accepted after Reading Days unless otherwise worked out with me.

University excused absences will not cause point deductions as long as you get in touch with me **within 24 hours of the absence** to arrange a new due date and provide proof of the reasoning.

Online Submissions:

Although we intend to have everything (except the SmartBooks) in person this semester, if circumstances change and we are required to do portions online again, the following rules will apply.

Technical Problems – If you have a technical problem that prevents you from completing an assignment by the deadline, you must let me know within one day (24 hrs) and document the issue in order to receive an extension. If you cannot prove the issue, an extension will not be granted. When you have an issue, let me know immediately and contact Information Technology Services (available at the bottom of the TAMUSA homepage or the left column on Blackboard).

- If an assignment is not showing up online during the time it should be assigned, it is your responsibility to let me know <u>before</u> the assignment's due date and document the page showing it is not appearing.
- If you do not tell me about technical issues until after the deadline, I cannot verify the problem or tell what was wrong and <u>will not reopen it</u>. If you tell me after the fact that you had a technical problem without providing any proof, I will not allow an extension.
- No extensions are granted for Virtual Labs since you have several weeks to complete them.

Dropping:

If you wish to drop this class, it is your responsibility to tell the teacher so a "W" can be entered for your final grade.

Students who drop before **census date (September 11th)** may be able to get part of their tuition refunded and the class will not show up on their transcript. After that, no money is returned.

The last day to automatically withdraw yourself from the class is November 11th. After that, you will need to fill out a withdrawal form personally by November 19th. If a student chooses to withdraw, the class will still show up on their transcript, but a "W" will be entered as the grade so it does not count against their GPA. Each student is allowed 6 drops/withdrawals in their college career.

If a student does not withdraw by the deadline, then a final grade will be entered for that student.
