Catalog Course Description: This course introduces the nature and structure of the US and Texas legal systems; the basic principles of legal reasoning; and laws having a substantial impact on business including contracts, business organizations, and the Uniform Commercial Code.

Student Learning Outcomes: Upon completion of this course, you should be able to:

- Understand Business Entities including the advantages and disadvantages of each.
- Analyze if a valid, enforceable Contract exists.
- Evaluate case problems using Legal Reasoning.

Grading Policy:

- **Simulations:** Most weeks, students will complete a simulation (also called an ABA) through McGraw Hill Connect. You will have two attempts to complete each simulation. Late submissions will be accepted for five additional days (i.e. until the following Wednesday). Your lowest simulation grade will be dropped. The average of your simulations will be 50% of your course grade.
- **2 Exams:** This course will have two (2) exams (including a comprehensive Final Exam). Exams will be offered in an asynchronous format during the final exam week. Exam 1 will be 25% of your course grade and the Final exam will be 25% of your course grade.
- **Extra Credit:** This is NO extra credit available in this course. [Not even if you email me at the end of the semester asking.]
- **Academic Dishonesty:** Any assignment found to contain plagiarized material or be the result of any academic dishonesty will receive the grade of zero. In addition, two instances of academic dishonesty will result in the grade of F being assigned for the course.

Make up exam policy:

Exams: You must provide prior notice if you miss an exam in a non-emergency situation. Failure to do this will result in a 20-point reduction in your exam grade. Definition of a Credit Hour:

“A credit hour is an amount of work that reasonably approximates: not less than one hour of classroom or direct faculty instruction and a minimum of two hours out of class student work

each week for approximately 15 weeks for one semester, or the equivalent amount of work over a different amount of time; at least an equivalent amount of work as outlined in the item above for other academic activities as established by the institution including laboratory work, internships, practicum, studio work, and other academic work leading to the award of credit hours. (This information is in accord with federal regulations regarding the definition and assignment of credit hours under section 600.0 and 600.24(f) of the Higher Education Opportunity Act.)

“A credit hour represents a unit of measure of instruction consisting of 60 minutes, of which 50 minutes must be direct instruction over a 15-week period in a semester system. Academic administrative units are responsible for ensuring that credit hours are awarded only for work that meets this requirement. (This is in accord with The Texas Higher Education Coordinating Board definition.) Transfer credits will be evaluating for equivalency to this requirement. Students should expect to invest a minimum of two hours of additional work for each hour of classroom or faculty instruction per week.” 2019-2020 Catalog page 103

Therefore, this course requires 3 hours of class time plus a minimum of 6 hours of homework per week.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
