Catalog Course Description: This course introduces comparative law; the nature and structure of international law; international agreement governing dispute resolution, trade, the sale of goods, and direct foreign investment; and the legal risks of international business.

Prerequisites: BLAW 3341

Student Learning Outcomes: Upon completion of this course, you should be able to:

- Understand the international legal framework and regulatory environment in broad terms and its relevance to international business.
- Analyze the basic legal elements of international transactions of goods.

- Identify key laws that govern international trade.
- Identify various legal forms to protect intellectual property in international business.
- Describe international conflict resolution mechanisms to solve trade disputes.

Grading Policy:

- **Class Participation:** Students will discuss course material in class. In class participation will be 15% of your course grade.
- **2 Exams:** This course will have two exams (including a comprehensive Final Exam). Exams will consist of short-answer style and case problem style questions. Exams will be completed in person. The first exam will each be 20% of your course grade; The Final Exam will be 20% of your course grade.
- **Paper on Foreign Legal System:** Students will research the legal system of another country and write a paper. Details will be provided separately. The paper will be 25% of your course grade. Important milestones are noted on the course schedule below.
- **Presentation:** Students will give a presentation on the legal system they researched for the paper. The presentation will be 10% of your course grade. Details will be provided separately.
- **Attendance:** Attendance is required. To be counted as present, you must attend the entirety of the class session. Arriving late or leaving early will count as a ½ absence. Attendance will be 10% of your course grade. Your attendance grade will be the percentage of classes you attended. This means that each class you miss lowers your attendance grade by about 7.14 points. If you must miss multiple classes for medical reasons or if you require an accommodation, please provide documentation through the Dean of Students office or Disability Support Services.
- **Extra Credit:** This is NO extra credit available in this course. [Not even if you email me at the end of the semester asking.]
- **Academic Dishonesty:** Any assignment found to contain plagiarized material or be the result of any academic dishonesty will receive the grade of zero. In addition, two instances of academic dishonesty will result in the grade of F being assigned for the course.

Make up and Late Assignment/exam policy:

Discussion Assignments: Late submissions will be accepted for one additional week, but only at half credit.

Exams: You must provide prior notice if you miss an exam in a non-emergency situation. Failure to do this will result in a 20-point reduction in your exam grade. Any make-up exams should be taken within one week of the schedule exam date. Taking the Final Exam late may result in an incomplete for the course.

Papers: Late paper will lose 10 points per calendar day.

Presentations: Students will receive no credit for missing a presentation without prior notice in a non-emergency situation.

Definition Of a Credit Hour:

“A credit hour is an amount of work that reasonably approximates: not less than one hour of classroom or direct faculty instruction and a minimum of two hours out of class student work each week for approximately 15 weeks for one semester, or the equivalent amount of work over a different amount of time; at least an equivalent amount of work as outlined in the item above for other academic activities as established by the institution including laboratory work, internships, practicum, studio work, and other academic work leading to the award of credit hours. (This information is in accord with federal regulations regarding the definition and assignment of credit hours under section 600.0 and 600.24(f) of the Higher Education Opportunity Act.)

“A credit hour represents a unit of measure of instruction consisting of 60 minutes, of which 50 minutes must be direct instruction over a 15-week period in a semester system. Academic administrative units are responsible for ensuring that credit hours are awarded only for work that meets this requirement. (This is in accord with The Texas Higher Education Coordinating Board definition.) Transfer credits will be evaluating for equivalency to this requirement. Students should expect to invest a minimum of two hours of additional work for each hour of classroom or faculty

Therefore, this course requires 3 hours of class time plus a minimum of 6 hours of homework per week. As we only meet half of our class hours in person, you must complete a minimum of 7.5 hours of work outside of class every week.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
