**Calculator: Scientific calculators are required for this course.** Only the use of models without data storage capabilities are approved for exams. Some good calculator examples are TI-30Xa (about \$9 in Amazon and Walmart), TI-30X (about \$13), Casio fx-300ES Plus (about \$13) or casio FX-300MS (about \$11). Rental calculators will be available for tests. They will cost \$1 to rent.

# **Course Description**

The second semester of a two-semester sequence, this course introduces many chemical concepts, problems, and calculations. Principles and quantitative relationships in chemistry that will be introduced include stoichiometry, chemical equilibrium, acid-base chemistry, thermochemistry, rates and mechanisms of reactions, changes of state, solution behavior, atomic structure, periodic relationships, and chemical bonding. Prerequisite: CHEM 1311 and CHEM 1111 with a grade of "C" or better Corequisite: CHEM 1112 (Laboratory).

# **Learning Objectives**

- 1. Identify different types of intermolecular forces present in a molecule and rank them by strength.
- 2. Understand phase changes, phase diagrams and heat of vaporization and apply those concepts to predict states of matter at different environmental conditions.
- 3. Calculate concentrations of solutions, convert between concentration units and determine how concentration affects boiling point, freezing point, vapor pressure and osmotic pressure.

- 4. Write solubility equilibrium expressions and calculate solubility product constants and explain how different parameters affect solubility.
- 5. Demonstrate their understanding of chemical kinetics by determining and analyzing reaction rate laws, identifying order of reaction and determine what factors affect reaction rates.
- 6. Write equilibrium constant expressions for chemical reactions as well as calculate the value of the equilibrium constant and the concentration of reactants and products at equilibrium.
- 7. Define and identify strong and weak acids and bases as well as make dissociation predictions based on their structure.
- 8. Solve acid-base problems, calculate pH and explain acid-base properties of oxides.
- 9. Develop a procedure to make a buffer given a specific pH.
- 10. Construct a titration curve for an acid-base couple and determine the chemical species present during various points of the titration.
- 11. Express the three laws of thermodynamics and interrelate the enthalpy, free energy and equilibrium constant for the reaction
- 12. Balance redox reactions, calculate cell potentials and make quantitative calculations based on electrolysis.
- 13. Identify modes of radioactive decay, balance nuclear reactions, calculate energy changes associated with nuclear reactions and explain, based on the kinetics of nuclear processes, how quantities of radioactive elements relate with time.

# **Course Responsibilities**
