Course Description:

This course examines a wide range of ethical issues in the field of criminal justice through a discussion of the various philosophical approaches to ethical decision-making. Topics covered include the use of harm to prevent harm; the use of discretionary decision-making; prediction problems; and ethical dilemmas faced by front police, prosecutors, defense attorneys, corrections officers, etc. in the course of their daily duties. *Note that some of the topics we may use as examples can be sensitive or polarizing. You are expected to be respectful of others and their opinions while in this course.*

Course Learning Objectives:


By the end of the course, students will be able to:

- Discuss and analyze various ethical philosophies.
- Apply ethics to CJ scenarios.
- Evaluate and defend various approaches to justices.
- Assess current CJ policies from an ethical perspective.

Students will demonstrate their learning by:

- Participating in weekly discussions.
- Sitting for a final exam.
- Writing an article critique.
- Completing a final presentation.

We will frequently be using the internet as a means to enhance our learning in this course. We will also be using computers for our online assignments. Assignments & Learning Activities

- 1. <u>Syllabus Quiz</u>: There will be a syllabus quiz due by the end of the day on the second Tuesday of the semester. This quiz will consist of 5 multiple choice questions and will be available on Blackboard from the first day of class to 11:59 PM on Tuesday, September 3.
- 2. <u>Exams</u>: There will be 2 exams over the course of the semester. Given the nature of the course, the exams will be applied, and will consist of five essay questions. Exam 1 will include all material up until and including the week the exam is given; Exam 2 will include material from after Exam 1 through the end of the semester. Students will have a list of possible essay questions two weeks before the exam to prepare for the exam, and five questions from that list will be selected at random that you will be required to answer. You may have a single cheat sheet to bring to class on the day of the exam; you may not write the essays beforehand and copy them down to submit for credit.
- 3. <u>Weekly Packback Assignments:</u> See below for the grading criteria. These are worth 25% of your final grade.
- 4. <u>In-Class Activities:</u> You will have several practical assignments in-class that will help emphasize the material that we have read about or that you have received a lecture on. These range from in-class discussions, to role-playing activities, to reflection assignments, though other types of assignments may also be used. I will drop your two lowest grades.
- 5. <u>Final Paper</u>: Students will select a criminal justice policy or practice and determine its ethics by applying a theory that we have discussed in class. Students should review the ethical theory(ies), provide an analysis of the chosen policy/program, and address what changes are needed to make a current policy or practice an ethical one according to ethical theory(ies). More specific instructions are to follow when we get closer to the due date.

- a. Paper topic Submit a proposed topic (5%);
- b. Reference Identify 5 peer-reviewed sources relevant to your topic and describe why they are useful to your presentation (5%);
- c. Final paper (15%)

Packback Assignments:

Each week, we will be having discussions on Packback Questions. Packback Questions allows us to engage in discussions through a virtual venue that can be then carried into our in-person class for more practical application. Packback Questions is an online community where you can be fearlessly curious and ask open-ended questions to build on top of what we are covering in class and relate topics to real-world applications.

You will be required to participate in discussions each week and it will account for 25% of your final grade. Each assignment will be worth 20 points and will be due no later than 11:59 PM EST on Tuesday evenings. I will begin grading assignments at this time every week, so I will need all assignments submitted by this time.

In order to receive full credit, you should submit the following per each deadline period:

- 1. A discussion question that you create based on the readings
 - a. Minimum Curiosity Score of 70; worth 8 points of each assignment
- 2. Responses to at least two classmates' discussion questions
 - a. Minimum Curiosity Score of 60; worth 12 points of each assignment
 - b. Responses to your classmates that respond to your question

Remember that you will only receive half credit for questions and responses that do not meet the minimum curiosity score.

To register for Packback:

- 1. An email invitation will be sent to you from help@packback.co prompting you to finish registration. If you don't receive an email (be sure to check your spam), you may register by following the instructions below:
- 2. Create an account by navigating to https://app.packback.co and clicking "Sign up for an Account"

Packback will require a paid subscription of \$29. This is in addition to the textbook. Please reach out to me immediately if you are waiting for financial aid, or if you do not presently have the finances to purchase this subscription.

Grading Information:

The method for submission of each assignment will be made available to each student through either oral instruction, a written set of instructions, or a rubric for an assignment. I anticipate grading and returning assignments within two weeks of their submission.

If you have questions about a grade on any assignment, quiz, or examination, you will have ONE WEEK after the grade is posted to come to be with questions about the grade. After that week, your grade will stand as is (even if you did not check your grade in the week-long time period). Should you raise serious concerns about how a learning activity was graded, I reserve the right to regrade the whole assignment.

I recommend drafting any initial reaction emails after a grade is posted; sending your initial response is reactionary but waiting at least 24 hours will allow you sufficient time to process. If you choose to email immediately, be sure to use professional language in your email.

I may or may not round the final grades. Extra credit will ALWAYS be announced; do not ask for extra credit at any point during the semester. Rounding is also inherently unfair, please do not ask if I can round your grade up to get you to the next letter grade. Be sure to do your best work on each assignment and ask for help when you need it to prevent panic at the end of the semester.

I will not speak with parents about grades or assignments, unless the proper procedures have been followed to permit me to do so. As a college student, you are an adult and capable of managing your own academic affairs. However, if you are unsure about how to handle a particular academic situation, be sure to ask. I am happy to discuss navigating university policies or questions about your grades during office hours.

Course Policies

Attendance: Attendance for my courses is not mandatory, though students are always expected to attend all scheduled activities for the courses for which they are registered. However, it is important to note that with the size of the class this semester, your absence will be extremely obvious. You must attend class leading up to Census Day (September 11, 2024) and complete one assignment to be counted as present when the census is taken.

Make-up and Late Work Policy: If you miss an assignment submission deadline because of participation in a university-sanction activity, arrangements to make-up missed work can be made by contacting me. However, this will require documentation. This will include, but is not limited to, providing a letter with your orders for military services, or a doctor's note if you are ill. If you experience any technical difficulties prohibiting you from completing assignments, you must document this issue via screenshot.

<u>Life Happens Pass</u>: Life happens regardless of our plans. To recognize this, you will be granted one "Life Happens" pass in which you will be able to submit an assignment or sit for an exam up to two weeks after they are due. Please send me an email with the subject line "Life Happens" within two days of the assignment's deadline, unless there are extenuating circumstances, and have the body of your email only consist of the assignment or exam in question, and we will work out a plan together on how to get your work submitted.

I have the Life Happens pass to allow for things that are completely out of your control, but you are responsible for keeping track of the work that is not part of your Life Happens pass. You will otherwise be expected to maintain the pace of the course.

All assignments are to be submitted on the date they are due. In the event of planned excused absences late work will ONLY be accepted by an alternate due date that is previously agreed upon by the student and the instructor. Late work will not be otherwise accepted.

Electronics: You may use a laptop or tablet to take notes, but if either of these become a distraction to you or another student, you may be asked to find an alternative form to take notes. Phones are generally prohibited, though I will allow you to take pictures of PowerPoint slides if you need to. Electronics will be prohibited during exams. <u>Financial Aid and Verification of Attendance</u>: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
