Department Offering the Course: Biology

Recommended prerequisite: MATH 1314 Successful completion of College Algebra or concurrent enrollment in higher-level mathematics is recommended.

Materials Required: Lab handouts (provided by instructor)

Course Description: This course provides hands-on laboratory experiences that highlight the fundamental molecular, cellular, and genetic principles characterizing living organisms. The scientific method in the discovery of these principles will be the primary focus of the hands-on activities. This course is designed for students majoring in science fields and is a co-requisite for students taking BIOL 1306.

Learning Outcomes:

- 1. Students will develop critical thinking skills, communication skills, and Empirical and Quantitative skills. Students will learn to work as a team.
- 2. Students will understand and apply the scientific method to novel questions in order to develop a strategy to answer those questions.
- 3. Students will learn how to collect and analyze scientific data through hands-on activities in which they gather the data.

Required:

- 1) Signed safety agreement prior to start of second lab period.
- 2) Lab coats must be purchased and worn in the lab every week. If you forget your coat, you will be required to rent one for \$2 or leave the lab for the day and take a zero.

Grading Scheme:

Attendance – Mandatory. Attendance counts for 30% of your course grade. In addition, if a student misses more than 3 laboratory classes (excused or not) in a regular semester then the student will automatically fail the course.

Lab handouts and/or quizzes: Worksheets/quizzes count for 40% of your course grade.

Lab Report: Lab Report on Yeast experiment will count for 10% of your course grade.

Final Exam: The final exam will count for 20% of your final course grade.

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

<u>The Six-Drop Rule:</u> Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
