# **Course Requirements and Expectations**

<u>Catalog Description</u>: In-depth study and applications of polynomial, rational, radical, exponential, and logarithmic functions, and systems of equations using matrices. Additional topics such as sequences, series, probability, and conics may be included. This course meets the standards for the Mathematics category of courses under the core curriculum. This course acts as a support course for Math 1314.
