Course Description: An independent review of literature and a laboratory or field problem yielding a formal report on the research.

Course Objective: The course provides students with the opportunity to develop, conduct, analyze, and interpret research in the exercise science field related to health, fitness, and human performance.

Learning Outcomes: Upon completion of this course, each student will be able to:

1. Describe the nature of research and explain the scientific method.
2. Understand the various steps of the research process and the factors that must be considered when selecting a research question.
3. Read and comprehend related literature and generate a working problem in which he/she is particularly interested.
4. Understand the role of the hypotheses and hypothesis testing in the research process.
5. Develop a hypothesis for a research project and synthesize this information to prepare a short review of literature.
6. Complete a human subjects application and attain simulated approval through the A&M-SA IRB.
7. Test a hypothesis and obtain data, analyze, and interpret results by carrying out a small research project in a specific exercise science-related topic.

Assignments: All assignments (e.g., presentations, IRB, CITI, review paper, etc.) are due at set specific times throughout the semester. Details of each assignment will be provided in class.

Of note, late assignments will not be accepted (i.e., 0 point).

Extra Points: If you participate in research (and submit the evidence of participation) from the Department of Counseling, Health and Kinesiology, extra points will be added to your final points for the grade.

Academic Dishonesty: Students are expected to do their own course work. Academic dishonesty (e.g., cheating, plagiarism, fabrication, lying, bribery, threat, etc.) is a violation of the Student Code of Conduct; therefore, the instructor will report any form of academic dishonesty to the Office of Student Rights and Responsibilities.

Attendance: Students are expected to attend all scheduled classes and may be dropped (or get F) from the course for excessive absences. 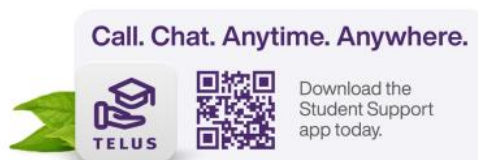

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Students' Responsibilities
