COURSE POLICIES

ATTENDANCE:

NETIQUETTE:

15 Essential Netiquette Guidelines to Consider in Online Learning

- Before posting your question to a discussion board, check if anyone has asked it already and received a reply.
- Stay on topic. Don't post irrelevant links, comments, thoughts or pictures.
- Don't type in ALL CAPS! If you do it will look like you are screaming.
- Don't write anything that sounds angry or sarcastic even as a joke, because without hearing your tone of voice, your peers might not realize you're joking.
- Always remember to say "please" and "thank you" when soliciting help from your classmates.
- Respect the opinion of your classmates. If you feel the need to disagree, do so respectfully and acknowledge the valid points in your classmate's argument. If you reply to a question from a classmate, make sure your answer is accurate!
- If you ask questions, many people respond. Summarize all answers and post that summary to benefit your whole class.
- Be brief. If you write a long dissertation in response to a simple question, it's unlikely that anyone will spend the time to read through it all.
- Don't badmouth others or call them stupid. You may disagree with their ideas but don't mock the person.
- If you refer to something your classmate said earlier in the discussion, quote just a few key lines from their post so that others won't have to go back and figure out which post you're referring to.
- Before asking a question, check the class FAQs or search the Internet to see if the answer is obvious or easy to find.
- Check the most recent comments before you reply to an older comment.
- Be forgiving. If your classmate makes a mistake, don't badger him or her for it. Just let it go.
- Run a spelling and grammar check before posting anything to the discussion board.

COURSE STRUCTURE & ASSIGNMENT DESCRIPTIONS

ASSIGNMENTS:

The final grade will be determined by the accumulation of points earned by the following:

Assignments	Description
Article Summary	An article will be assigned (or selected) to (by) one student for presentation for each week. Other students except the presenting student are expected to upload the summary (discussion) of articles (1 page, pdf or Word file, 3pts value) on the dropbox AND discussion board on the blackboard by the due date (5 pm on the presentation date).
Discussion Questions	You will be required to create and submit 4 discussion questions for each article covered in this class. These questions will be derived from the weekly reading that will be assigned. You will not only create these questions but you will be prepared to speak to each of the questions and help stimulate the group discussion around these questions. Presentors: Please email the instructor three research papers by the second week of the semester. The instructor will approve one of the articles. Once you receive confirmation, upload the approved article to the designated forum on the Blackboard discussion board. Attendees: Please upload the summary (discussion) of articles and 4 questions on discussion board – Blackboard by 5 pm on the presentation date.
Research Paper & Formal Presentation	The purpose of this project is to explore a relevant topic related to physical education or physical education teacher education. All topics must be selected and approved by the professor within two weeks of the semester. Duplicated topics will not be allowed and topic apprioval will be granted in the order of request. I will base my evalution of the paper on the adequate coverate of the chosen topic (previous and current research and the overall quality of the scholarly communication (quality, creativity and originality). Research Paper All submitted paper should be at least 10 pages, typed and couble-spaced. A legible 12 pt. Times New Roman should be bsed and margins should be one inch on all sides. When citing others' work (including text and images from printed and

online resources) you should appropriately and fully reference all work using APA style. Writing shuld be clear and concise. Correcting spelling, punctuation and grammar are expected. All aspiring grauate students should strive toward constant improvement of writing skills.

The paper should be organized as a literature review article. The paper should follow a professional jousnal format and the paper shold summarize the current ody of knowledge of the chosen topic. This will include an introduction, body pragraphs, conclusion, and a reference list. Table, diagrams, and other visual content may be included and should be appropriately labled and referenced.

A minimum 10 current references, published within the last five years, are required. In addition to the current references, relevant older references may be included. At least 80% of the references must be from peer-reviewed journals. All references myst be appropriately cited within the paper and fully referenced in the "Reference List"

Formal Presentation

Presentation should be at least 1 hour including Q&A and discussion. A presenter will lead it with the assumption of being the first or corresponding author of the article presented. An article you want to present can be selected from the articles posted on Bb (research article preferred) or you can select any article that is related to our topic. Email me with the title of the article you want to present by **September 13**th, **5PM**. To avoid the selection conflict, it will be a first come, first served policy. If you select an article other than the one posted on Bb, you should indicate it in the e-mail and it should be approved by Dr. Kwon.
