Course Description:

This course is designed to introduce students to research methods in the field of criminal justice.

Course Learning Outcomes:

The primary objective of this course is to introduce you to research methodologies used in criminal justice research. Many of the elements of this course will help you improve your critical thinking and problem-solving skills, which may be carried over into non-research related aspects of life. Upon successful completion of this course, you will have an increased understanding of concepts and issues in research methods. The four main topics that will be covered in this course are: 1) Introduction to Research, 2) Research Design, 3) Data Collection, and 4) Interpreting Data.

Lectures:

During lectures we will discuss concepts, applications and implications, and current examples. Completing the assigned readings will help you enhance your understanding of lecture material. Lectures will be provided to you via Black Board. Specifically, lectures will be recorded via Voice Thread and posted on Black Board.

Class Format:

This course will consist of lectures, quizzes, exams, discussion forums, and assignments. You are expected to complete all the assigned readings, assignments, discussion forums, quizzes, and exams.



Assessments

Assignments (40 points):

You will complete Two assignments during lectures. Instructions and due dates for each assignment will be provided on Black Board.

Discussion Forum (200 points):

You will complete ten discussion forums worth 20 points (please see rubric in the instructions document provided on BB) each throughout the semester. Your main goal here is to argue your opinion regarding each topic you are required to read each week. Detailed instructions about the discussion forum are provided on BB. Minimum word count for this assignment is 600 for your discussion, and 300 (each) for your peer response. Additionally, APA format is required. Instructions, due dates, and grading rubric are available on Black Board under “Discussion Example” tab.

Exams (120 points):

There will be three exams during the semester. The exams will include a variety of question types such as multiple choice, true/false, fill in the blank, and essay questions. The exam questions will be drawn from the assigned readings and lecture notes. You will have 60 minutes to finish the exam. You have one chance to take the exam so do not start unless you are ready. Exam is available on Black Board.

Research Report (50 points):

Final exam will be replaced with a Research Report. Instructions, due date, rubric, and example is provided on Black Board.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV



funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Students' Rights
