**Course Overview**

Origin and development of the U.S. Constitution, structure and powers of the national government including the legislative, executive, and judicial branches, federalism, political participation, the national election process, public policy, civil liberties and civil rights.

1. Explain the origin and development of constitutional democracy in the United States
2. Demonstrate knowledge of the federal system
3. Describe separation of powers and check and balances in both theory and practice
4. Demonstrate knowledge of the legislative, executive, and judicial branches of the federal government
5. Evaluate the role of public opinion, interest groups, and political parties in the political system
6. Analyze the election process
7. Describe the rights and responsibilities of citizens
8. Analyze issues and policies in U.S. politics

**Course Requirements**

Exams – There are three exams in this course, one covering each of the majors sections of the course (i.e. Foundational institutions of American politics, Institutions of American politics, and Intermediaries of American politics). The exams will take place in class and are scheduled in the syllabus (see below). Each exam will consist of a combination of multiple choice, true/false, and

short answer questions and will be worth 100 points each. A study guide will be provided prior to each exam. (300 total points)

Quizzes - There are 11 weekly quizzes in this course. Each quiz will cover the chapter for that week. Each quiz is worth 12 points with 1 point per question. The quizzes are taken through blackboard, are timed, and are available from Thursday after class to Friday at 11:59pm. Students are to work on the quizzes on their own. I will drop the two lowest quiz scores and there are not make up quizzes available (108 total points)

Participation/In Class Assignments – The participation grade for class is based on two components – class participation and completion of in class assignments. For the most part as long as I can tell the student put in a good faith effort on the assignments and their participation, they will receive full credit but if not, they will be docked points. The assignments are designed to be completed in class so that means students must be present in class to participate. Make up in-class assignments will be given only when the students are gone from class for an excused absence (i.e., illness or university sponsored event) (100 total points)

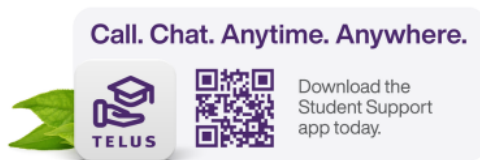

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student’s GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as “F” grades and will impact the student’s GPA.

4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

#### *Students' Responsibilities*

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, [Student Code of Conduct](#), on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
