# **Syllabus**

## **BCOM 3304: Business Communication**

## **Course Description:**

Principles of business communication through letters and reports. Clear, accurate, and forceful writing; practical psychology; and business reports with implications for international business.

Prerequisites: Completion of the College of Business prerequisites, ENGL 1301 and ENGL 1302.

Students who do not meet the pre-requisites must contact the instructor immediately.

## **Learning Outcomes:**

After successful completion of this course, students will be able to:

- 1. Communicate through use of appropriate English, both written and verbal, by writing effective business letters, emails, and reports, and by delivering oral presentations.
- 2. Demonstrate proficiency in the business writing process by analyzing the audience, planning, organizing, composing, formatting, and revising common types of business messages. This is WI and students will polish their writing skills by drafting, editing, and correcting their submission before turning in the final draft.
- 3. Analyze the ethical and intercultural implications of your communication choices and demonstrate respectful and appropriate business vocabulary and messages appropriate for situations and audiences by appropriately providing and receiving written and verbal feedback.
- 4. Learn the principles of searching for employment by examining the organizations, writing employment documents, and preparing for interviews.

## **Required Materials:**

Students are encouraged to select the format of their choice (ebook, kindle, hardcover, paperback, loan options vs. buying options) for the required reading materials and supplemental learning materials, such as flash cards, integrated learning software, supplemental exam preparation materials based on their needs, resources and learning style preferences.

Essentials of Business Communication, 12th Edition, by Guffey and Loewy. Cengage.

#### Other Recommended Reading Materials:

This class will enable you to become a leader in your learning journey. As such, you will be provided with lots of additional and optional suggestions for reading materials, publications and books from various sources. It is up to you, your personal learning journey and desire to improve your skillset to explore new horizons throughout your college career that will help you thrive in your professional and personal sphere based on your end goals. As a general rule, I highly encourage you to look into improving your skillset through additional resources that are recommended to you by professors, mentors and leaders. #### **Time Commitment:**

You are expected to spend 4-9 hours per week for the course. Based on the background, some student may require more time. Time spent may be longer when assignments/exams are due.

### **Methods of Instruction:**

- This course includes required readings, multimedia stories, handouts, guidelines, field-based examples, student-centered instructional tasks, interactions and reflection through a variety of interactive activities.
- Assignments are designed to apply theory to practice.
- Reflection on processes, practice, and feedback will be required.
- Assessments focus on understanding and performance-based competencies required to obtain additional skills designed to help students to become more marketable in their chosen career.

#### Course design:

This class will enable students to become independent and active learners via the use of experiential, self-reflective, cutting-edge adult learning methods using asynchronous and synchronous learning styles. As that, this course is constructed as a community of learners, where everyone, not just myself, is a creator and holder of knowledge. Thus, you are expected come to class prepared to engage, ask questions, and work collaboratively with your colleagues in groups. My pedagogical approach to this course assumes that everyone has valuable lived experiences that can be incorporated into the classroom, therefore, everyone has value to add to our discussion and learning environment. My primary role within the class is to pose questions, facilitate discussion, clarify points, and have everyone develop their own understanding of course material as it relates to their specific area of interest and specialization.

In the long term, students will acquire learning methods, soft skills and additional tools that will enable them not only to become lifelong learners but also to be equipped to stand out during job interviews and conversations with employers. The course is rigorous and challenging. The

structure of the class makes your individual study and preparation outside of class extremely important. Studying the assigned chapters, online modules, additional readings and all assigned materials before class is expected.
