Course Purpose and Philosophy:

The purpose of the course is to stimulate a better understanding of the rise of fascism in Europe during the interwar period (1919-1939) with specific emphasis on the development of National Socialism in Germany. The course focuses on the political, social, cultural, and economic conditions that shaped the Weimar Republic as well as the radicalization of German politics in this period on both the left and the right.

The course also examines the persona and role played by Adolf Hitler in the development of the Nazi state and his influence on the foreign and domestic policies of the Third Reich. We will discuss the influence of the Nazi Party, the SS and Police complex, the military, and big business prior to the Nazi seizure of power and during the period of the Nazi dictatorship (1933-1945).

The course stresses the relationship of Nazi policies and actions regarding Jews to their broader aims of domination, conquest and subjugation of the whole of Europe. It traces the changes in policy throughout the period from 1933 to 1945 and focuses on the ultimate inauguration of the practice of total annihilation after the invasion of the Soviet Union in June 1941. The course provides insights into how and why these changes occurred when they did, and why those who were victimized by the unfolding disaster were caught unaware.

At the conclusion of the course, you will have an understanding of the social, cultural, political, economic, and military developments that led to and shaped the rise and fall of totalitarian control of German society between 1933 and 1945. The quality and depth of intellectual rigor that you bring into the classroom each day will determine the value that you receive from the course and the benefits that accrue to you today and in the future. I look forward to our journey together.

Course Objectives:

- **Identify the circumstances in Central and Eastern Europe that led to the rise of fascism in Europe and the emergence of Nazism during the interwar period.**
- **Comprehend the social, political, economic, racial, and military policies and goals of Nazi Germany.**
- **Identify and evaluate the changes in Nazi policy toward the Jews and other persecuted groups between 1933 and 1945.**
- **Evaluate the role of gender norms in shaping expectations in Nazi Germany**
- **Analyze the scope of the events of the Holocaust and its relation to the military events of World War II.**
- **Communicate clearly and concisely in written and verbal assignments.**

Critical Book Quiz/Essays: For each of the required course texts, there will be a quiz and an in-class essay.

Classroom Participation: These points will be based attendance **and** the quality of your contributions to discussions in the classroom. Learning is a “student-centered” activity that requires your thoughtful participation and analysis of ideas presented during class. You will be graded on the quality of your contributions to the class and your ability to analyze and discuss course concepts.

Primary Source Blackboard Discussions/Visual Source Microessays: Students will participate weekly in a two-part blackboard discussion. Primary source readings and a visual source will be provided each week for evaluation, and students will post responses to the questions posed. Student responses should be **at least one complete paragraph of no less than 150 words**. The discussion grade will be based upon four factors: (1) evidence used to support your response, (2) level of analysis (3) length/completeness of the response, and (4) writing style/proofreading. The written primary source discussion boards will open on Tuesday at 2:00 pm each week and close on Sunday at **10:00 pm**, there is no excuse not to participate. Makeups will not be allowed unless a student can prove through written documentation that he or she has been sick for an entire week. (Click on the discussion tab in blackboard to find the weekly

discussion.) In addition, a **second Discussion Board will open on Sunday at 7:00 pm related to a visual primary source and will close on Tuesday at 12:30 pm.**

Attendance Policy

Regular attendance is required. I take attendance at the beginning of class and we conduct community building at the start of class so being on time is important to your learning experience. Early departures from class should be cleared with the instructor before the start of class. As much of the course work happens in class, missing 25% of the classes or more will result in a minimum of a letter grade deduction from the final grade. This includes both excused and unexcused absences. This does not include university-sanctioned absences for which I receive notification from the University. All students (whether present or absent) are responsible for all announcements made in class and all assignments given in class because it is sometimes necessary to make changes to the syllabus.

Cell Phone Policy

Cellular phones and other electronic devices should be turned off during lectures. Laptop computers may be used to take notes during the class.

Make-up Exam Policy

Based on instructor discretion, students may be allowed to take a make-up exam in the event of extraordinary circumstances that prevent the student from taking the exam at the scheduled time. Late Assignments

An assignment is considered to be late if it is not turned in at the start of the class period during which the assignment is due. Late assignments without an acceptable excuse as determined by the instructor will be recorded as a zero or may incur a penalty.

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. The Six-Drop Rule

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
