# **COURSE DESCRIPTION**

This course offers an introduction to certain vital aspects of the history of the United States from European colonization to the end of the Civil War. It will focus on four: the nature and impact of European colonization; how the U.S. came to be an independent nation; how slavery almost destroyed that nation in the 1850s and 1860s; and how the U.S. has continually struggled to deal with its diversity. Through the textbook and readings, students will be exposed to the different ways that historians "do" history; thus, we have works widely regarded as a model of the new "inclusive" history. To give you the experience of working with primary sources, the "stuff" of history. Toward that end, we are reading the autobiography of Frederick Douglass.

The greatest problem of a course that attempts to cover over three hundred years of U.S. history in 16 weeks is that exceedingly hard choices have to be made. We cannot deal with everything that most historians would consider essential in a survey of American history, let alone all of the topics that are interesting and rewarding. Thus, I emphasize that this is an <u>introduction</u> to U.S. history that I hope will encourage you to explore certain aspects of it in greater depth in other courses or on your own.

# **LEARNING GOALS**

Upon successful completion of this course, students will:

- 1. Create an argument through the use of historical evidence.
- 2. Analyze and interpret primary and secondary sources.

3. Analyze the effects of historical, social, political, economic, cultural, and global forces on this period of United States history.

#### Attendance & Participation Policy (10%):

I take attendance every class period. The course meets once per week, so up to two absences are allowed. Being absent more than that will affect your attendance grade and make it difficult for you to do well in the course. The Learning Management System will automatically drop the lowest 2 absences so there is no need to email me if you will be out.

**Blackboard:** This hybrid course has a Blackboard site. The syllabus, additional reading assignments, videos, DB and study guides will be posted there, as well as announcements and grades throughout the semester. I do not post lecture notes online—you must attend class and take your own notes. If you are absent, you will need to get lecture notes from someone else in the course.

The syllabus is subject to change, and I will let you know in advance of any changes that need to be made during the semester.

Laptop computers may only be used during class time to take lecture notes. Any other purpose is not allowed.

#### Weekly assignments (10%):

Students will be asked to submit low-stakes quizzes or written assignments based on the lecture videos, films and primary sources. Write-ups will be graded on the quality of your contributions and your ability to analyze, think critically, and discuss course concepts. Note: No late work will be accepted.

#### Exams (60%)

You will have three exams proctored during our in-person meetings on 9/24, 10/22, and 12/3. The exams will be a mix of multiple choice, T/F, matching, short-answer, and essay questions. Before each exam, you will have a review and a study guide to help you prepare for the examination.

#### Make-up Exam Policy:

Exams only will be given on the date assigned on the course calendar. Makeup exams only are allowed for emergencies such as debilitating illness, a death in the immediate family, and religious or school functions. In any case, documentation must be provided in order for the student to be allowed

a make-up exam. Missed exams must be made up within a week at the testing center. The testing center has it's own policies and procedures. Students must register for an exam appointment at <u>https://www.tamusa.edu/academics/testing-center/index.html</u>

The testing center does not accept walk-in's. Students must register 12 hours in advance of the day you want to test. Once you have scheduled the test, send me a courtesy email to let me know what day to expect it so that I can pick it up. As you noticed, these are all steps that are initiated by the student, and not the professor--that's more work on the student. At the discretion of the instructor, the make-up exam may not be the same format as the class exams. The Testing Center exam is the final make-up available so if you miss this second opportunity, you will receive a 0.

#### Essay Exam (15%)

Students will complete a short in-class essay on November 5 for Frederich Douglass. The instructor will provide students with an essay prompt at the beginning of class. The short essay will be completed within the first 30 minutes of class, with time following devoted to discussing the book. Students will need to bring paper and pens to class. The essay should include a strong thesis statement supported by evidence from the text to illustrate the student has completed the assigned book. Make-up essays only are allowed for emergencies such as debilitating illness, a death in the immediate family, and religious or school functions. In any case, documentation must be provided in order for the student to be allowed a make-up essay.
