**Catalog Course Description:** International trade theory and policy and international monetary economics; balance of payments and exchange rate theory. Apply trade theories and models to explain why countries trade, gains from trade and trade patterns. Trade unions, tariffs, quotas and other non-tariff barriers to trade. Reasons and consequences of trade deficits. *Prerequisite:* Admitted to the College of Business, ECON 2301, and ECON 2302.

**Course Objectives:** The objective of the course is to familiarize students with the modern analytical tools and methods used in international trade and finance. The focus of the course is on trade theories, tariff and nontariff trade barriers, trade regulations, balance of payments, and foreign exchange.

**Prerequisites:** Admitted to the College of Business, ECON 2301, and ECON 2302. Students who do not meet the pre-requisites must contact the instructor immediately.

**Student Learning Outcomes:** After successful completion of this course, students will be able to understand:

- 1) What are basic trade theories in International Economics;
- 2) the welfare effects of trade restrictions;
- 3) trade regulations and Industrial Policy;
- 4) trade policies in the context of developing nations;
- 5) regional trading arrangements.

**AACSB Assessment:**

The College of Business is in the process of applying for AACSB accreditation. As part of that process, students will be assessed on program level outcomes based on course outcomes from various courses. The materials from this course may be used for assessing such program level outcomes, and hence students must follow the necessary rigor to ensure mastery and retention of the above course outcomes.

- **Computer Hardware:** In order to participate in the tutoring sessions (if offered) you will need a computer with an internet connection, a microphone and speakers/headphones.
- **Time Expectation for Coursework:** You are expected to spend 2-4 hours per week for the course. Based on the background, some students may require more time. Time spent may be longer when assignment/exams are due.

**Other Recommended / Reading Materials:** Additional reading materials are available on the course website as recommended by the instructor.

***Course Requirements every student must fulfill in order to succeed in course:***

1. Students should check the Course Calendar, Announcements, and Messages (e-mail) systems in Blackboard on a regular basis.

**Grading Policy:** The final course grade will be based on your performance on the quizzes, exams, assignments and class participation using the following weights:

The final letter grades will be assigned as follows: Above 90% ⇒ A; 80 – 89% ⇒ B; 70 – 79% ⇒ C; 60 – 69% ⇒ D; Below 60% ⇒ F.

This course has a requirement of a grade of C as a minimal grade for satisfactory completion of this course.

**Examinations and Quizzes:** There will be 2 mandatory midterm exams, and a mandatory final exam (as per university schedule). Being absent for an exam will result in a grade of zero for that exam and may result in a fail grade in the course. The exams will consist of conceptual multiple-choice questions, problem solving questions, and short essay questions. The exam materials will come from lecture notes,

the text, the homework, and class discussions. Questions will emphasize understanding and applications of concepts and topics covered in class.

**Assignments:** There will be 5 take home assignments during the course. Individual assignment statements and due dates will be posted through Blackboard. For all assignments, ALL intermediate work of the problem solution steps MUST be shown. This includes the use of the formula, the values substituted in the formulas for problem solution, as well the intermediate steps of the arithmetic computation. The units of measurement are extremely important and MUST be shown at each stage of the computation. Considerable points will be taken off for not following these requirements.

**Discussion:** There will be 4 discussion posts centered around certain economic topics, and the country you select for your final project. You will be given information on what will be covered and the format a week prior to help you prepare. This task is to help you gather information throughout the semester for your final project.

**Project:** There will a mandatory final project due at the end of the semester and discussed throughout the semester. You will select a country of your choosing (pending approval), outside of North America, and create a PowerPoint presentation detailing certain economic data. Information on the requirements and grading breakdown for this project will be discussed in class and posted on Blackboard.

#### **Use of Generative AI Permitted Under Some Circumstances or With Explicit Permission:**

There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.
