**Course Description:** Students will study the collection, analysis, presentation and interpretation of data, and probability. Analysis includes descriptive statistics, correlation and regression, confidence intervals and hypothesis testing. Appropriate technology used. This course meets the standards for the mathematics category of courses under the core curriculum.

Prerequisite: Evidence of math equivalent to High School Algebra II ("C" or higher) or placement.

Online Course Platform: Students will complete online homework assignments and track related grades by using Pearson's MyStatLab course platform (access codes are available in the Brytewave link via Blackboard).

All-important announcements, materials, and grades will be provided via Blackboard (BB) so it is important that you monitor activity on Blackboard frequently. Students are responsible for checking blackboard regularly for announcements, assignments, and other support materials posted on Blackboard.

**Required Textbook:** Fundamentals of Statistics Informed Decisions Using Data Sixth Ed., Sullivan (ISBN:). ## **Student Learner Objectives:**

- 1. Apply and explain the use of data collection and statistics as tools to reach reasonable conclusions.
- 2. Recognize, examine and interpret the basic principles of describing and presenting data.
- 3. Compute and interpret empirical and theoretical probabilities using the rules of probabilities and combinatorics.
- 4. Explain the role of probability in statistics.
- 5. Examine, analyze and compare various sampling distributions for basic discrete and continuous random variables.
- 6. Describe, compute and explain confidence intervals.
- 7. Solve and interpret simple linear regression and correlation problems.
- 8. Perform hypothesis testing using statistical methods and interpret results.

### **COURSE REQUIREMENTS and EXPECTATIONS**

**Class Attendance:** Students are expected to attend classes (lectures and recitation) as scheduled and be prepared to participate in discussions, in-class exercises, quizzes and problem presentation, and be aware of what has been covered in every class and any announcements and course policy changes made in class. Announcements and changes will also be communicated through Blackboard. You are welcome to ask questions during my office hours; however, it is your responsibility to learn the material. In addition, if you cannot avoid situations that prevent you from being on time or if you must leave early, please minimize class interruption.

**Electronic Devices**: Cell phones, laptops, I-Pads, Kindles, and other electronic devices must be <u>turned off</u> and <u>put away during class</u>. Anyone who is observed text messaging or using an electronic device during class will be **marked absent** as a further action will be asked to **drop the course**.

**Examinations:** There will be three exams during the semester and a comprehensive final exam (regular classroom/periods during finals week).

**Exceptions:** For a legitimate reason you may be granted a make-up exam by the instructor. Students will need to notify the instructor that they will miss an exam and provide a reason for their absence within 24-hrs of the scheduled exam date. regular time. Students who fail to follow prescribed procedures will receive a grade of **zero** on the missed exam.

**Homework:** You will be assigned homework problems via MyStatLab.
