Course Description and Material

<u>Catalog Description</u>: Study of the concepts of sets, functions, numeration systems, number theory, and properties of the natural numbers, integers, rational, and real number systems with an emphasis on problem solving and critical thinking. This course meets the standards for the mathematics category of courses under the core curriculum.

Prerequisite: MATH 1314 College Algebra or equivalent.

<u>Required Textbook</u>: Long, DeTemple, Millman, *Mathematical Reasoning for Elementary Teachers* (7th ed.), Pearson, ISBN-13: 978-0321900999.

<u>Required Equipment</u>: TI-30 series scientific calculator or equivalent. (Graphing calculators are not allowed during exams.)

<u>Student Learning Outcomes</u>: Upon completion of this course, students will be able to:

- 1. Interpret and apply Venn diagrams, elementary set terminology and functions in solving problems and in representing mathematical relationships.
- 2. Demonstrate an understanding of the structure of our base-10 system and various other numeration systems including positional and additive systems.
- **3**. Demonstrate an understanding of elementary number theory and its application to arithmetic and problem solving.
- 4. Demonstrate standard arithmetic algorithms.
- 5. Relate the course content to the teaching and learning of mathematics in the elementary school classroom.

MATH 1350 helps students develop Critical Thinking, Communication, and Empirical and Quantitative Skills by focusing on student understanding of essential mathematical concepts for secondary teachers to include recognizing, identifying, solving, analyzing and explaining applications in elementary educational settings.

NOTE: Each week a set of learning activities will be posted in a folder on Blackboard for that week. The folder will normally be made available at 8:00 AM on Monday morning with assignments (recordings, exercises in MyMathLab, assessments, etc.) due the following Sunday at 11:59 PM. Aside from the three hours that you spend viewing video recordings each week, you should devote at least another 6~8 hours to studying on your own: reading the book and lecture notes, working out your homework assignments, and solving some extra related problems for practice. You are responsible for any and all materials/topics discussed in this class and in the assigned textbook sections.

Course Expectations and Requirements

Examinations: There will be three exams during the semester:

- Exam 1 Window (60 minute exam): 0800 Thursday, September 26th through 1700 Saturday, September 28th
- Exam 2 Window (60 minute exam): 0800 Thursday, October 31st through 1700 Saturday, November 2nd
- Final Exam Window (120 minute exam): 0800 Tuesday, December 10th through 1700 Wednesday, December 11th

Students are expected to take all three exams in the scheduled windows. It is the student's responsibility to schedule test times with the Testing Center at Texas A&M University – San Antonio (https://www.tamusa.edu/academics/testing-center/index.html) for each exam.

Homework: There will be approximately 27 homework assignments to be completed in the MyMathLab site provided by Pearson publishing company. These assignments will generally be due Sundays at 11:59 PM. Which homework assignments are due each week will be determined by the weekly progress in recorded lectures. The assignments will be given in recorded lectures.

<u>*Quizzes*</u>: There will be eight Quizzes for this course that will be administered in the MyMathLab site.

Students can have group/team discussions about homework problems. However, each student must do his/her own work. Be mindful of academic integrity.

Examples of collaboration on homework:

1. A group of students studying together read a problem and then discuss verbally the techniques or strategies they will use to solve the problem. This level of cooperation is allowed.

2. One student writes a solution to a problem which other students then use as an example. This level of cooperation is NOT allowed.

No collaboration is allowed on quizzes.

Classroom Etiquette: Students are expected to refrain from distracting classmates as a result of off-task conversation, electronic devices, or other class interruptions.

Electronic Communication Devices: Electronic communication devices (e.g., laptop computer, tablet computer, cellular phone, smart phone) can be useful learning tools, but can also be distractions. Mathematical concepts often require *intense concentration* to grasp, so missing even a few words of classroom discussion can leave a student confused and frustrated. During scheduled classroom times, electronic communication devices are not to be used unless specifically authorized by the instructor. Unauthorized use of electronic communication devices during class time *will result in the student being dismissed from class*. If a student has an urgent situation (e.g., family member in the hospital), inform the instructor at the beginning of class that you wish to leave your cell phone on in case you receive an emergency call.

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
