Course Objectives:

The course provides in-depth insight about the promotion element of the marketing mix, including advertising, sales promotion, public relations, and personal selling. In the first half of the course, students learn theoretical perspectives of promotion. In the second half of the course, students will apply their understanding of promotion by developing an integrated marketing communication (IMC) plan for a small business.

Prerequisites: MKTG 3311

Student Learning Outcomes: After successful completion of this course, students will be able to:

- 1. Explain the importance of integrated marketing communications
- 2. Discuss factors that affect the promotion process
- 3. Identify the core elements of an effective promotion
- 4. Evaluate the effectiveness of a company's IMC
- 5. Describe best practices when promoting a product/service
- 6. Create an IMC plan for an actual business

In other words, the instructor will offer the student some flexibility on test location and the time to sit for the exam.

Course Assignments

Simulations:

Students have three attempts for each simulation and the best grade will be recorded.

Simulation 1: Market Segmentation: MPopins Backpacks ABA-Simulation

In this activity, you will play the role of a co-owner of MPoppins Backpacks. You and two college friends, Emily and Hannah, are starting a business from what was a college project. MPoppins Backpacks offers unique children movie character backpacks. You have been involved with every aspect of the small business and creating the niche. It is you and your business partners' responsibility to research and determine your market segment.

Simulation 2: Target Audience Identification: Recycled Trends- Simulation:

In this activity, you will act as the Account Planner for an agency that works with Recycled Treads, a shoe brand that makes their shoes from other recycled shoes/materials. You'll make decisions relating to who the Recycled Treads brand should target based on the information you learn about the brand and consumers.

Simulation 3: Positioning Strategy: HealthFizz Sports Drink-Simulation:

In this activity, you will play the role of the advertising consultant for HealthFizz, a company that sells sports drinks. Elexa (Advertising Director) and Jim (Marketing Director) have called you in to help them reposition their sports drinks because of a new competitor, Hype Nutrition, that have recently come into their target market and is greatly influencing their sales. You will provide Elexa and Jim with suggestions on what repositioning strategy they should use and many other influences to lead them back to being the number in the sports drink industry.

Simulation Reflections:

Students must create at least a 5-minute video reflecting on each simulation. Students should describe what they learned after taking the simulations, what they would do differently in the future, and how the lessons learned can help them in their careers. This video must be recording of yourself talking and with a camera on to record your face. Upload video to your YouTube Account and share the link to the video.

Chapter Quizzes:

Students will use Connect and Canva to complete chapter quizzes consisting of multiple-choice and true-and-false questions. These are to be completed outside class. Students have **25 minutes to complete 20 questions. Once the time is up, the quiz will auto-submit**. All quizzes use Proctorio; students must use Google Chrome on a desktop or laptop to complete the exams. Please click here for a student orientation video on Proctorio.

Class Attendance:

Regular class attendance is a signal of a student's commitment to the course. This is the easy part, show up before the class begins and do not leave until the class ends. Please make not of the requirements of this issue outlined below.

• Although I appreciate notification of a class absence, understand that telling the professor that you will be absent does not necessarily mean that your absence does not "count." Having tests, projects, papers, etc., in other classes is not a valid reason for class absence.

- Students are allowed one excused absence during the semester for any reason (e.g., sickness, family emergencies, weddings, oversleeping, car trouble, job interviews, etc.) with no questions asked.
- Beginning with the second absence, 10 points will be deducted for each additional absence. The only exceptions to this policy are students who may be participating in sports or academic competitions recognized by the university and only for the day(s) of competition.
