**Course Description:** Students will study the collection, analysis, presentation and interpretation of data, and probability. Analysis includes descriptive statistics, correlation and regression, confidence intervals and hypothesis testing. Appropriate technology used. This course meets the standards for the mathematics category of courses under the core curriculum. Prerequisite: Evidence of math equivalent to High School Algebra II (“C” or higher) or placement.

## Course Requirements and Expectations

**Class Attendance:** Attendance will be taken every class meeting. Attendance will not count as a grade, but it will be entered into blackboard for me to keep track of who is coming to class and who is not coming to class.

**Participation tasks:** Each week students will be required to participate in class by answering questions and or working problems on the whiteboard.

**Learning New Content:** In this class, your instructor will hold 6 class meetings each week during our scheduled class time. The class meetings will be held in Classroom Hall 110. If you miss a class, make sure to check Blackboard to see what you missed or ask a classmate.

**Homework:** All homework and quizzes will be completed online in MyMathLab (MML). You will need an access code that has been sent to you via Brytewave. Please check your student email OR look for the Brytewave link in your Blackboard course to find your access code. Read the announcements in Blackboard for all instructions. All due dates are listed in MML. You can complete the assignments until 11:59 pm of the due date listed. The homework may be attempted multiple times in order to increase your homework grade. No late assignments will be accepted nor make-ups allowed. You cannot work on homework during class.

**Quizzes:** Weekly quizzes will be due in MyLathLab. All due dates are listed in MML. Quizzes may be attempted three times, and each quiz attempt has a time limit. Only the highest score will be counted. Students should attempt the quiz multiple times in order to be prepared for the unit test. No late quizzes will be accepted nor make-ups allowed.

**Tests:** Four tests are scheduled during the semester and a comprehensive final exam. The day and time of each exam is listed in the class schedule. I will also announce in class and on Blackboard when a test is coming up. I will also give out a review for each exam. The tests will be taken in class only, and you will need to show your work step by step to get full credit for the problems. Each exam is timed. The class will be given 1 hour and 15 minutes for test. Students will be allowed to use a non-graphing calculator on the tests. Any missed exam counts as a 0 unless the student has a valid documented excuse and contacts me as soon as possible. Examples of valid documented excuses are sickness documented with a doctor's note, death in the family documented with a copy of the death notice, attending university-sponsored events with a Dean's excuse, etc. Minor headaches or attending sports events (without Dean's excuse) are not examples of emergency situations. **Final Exam:** In order to pass this class students must take a comprehensive final exam scheduled during Finals Week. Final exams cannot be rescheduled or missed (for dire and unforeseen medical or family emergencies, students must consult with me). **The final exam must be taken on its assigned day and time only. There will be no exceptions.**

**Gradebook:** The gradebook in Blackboard will show your current weighed grade. The grades in MML will be imported to blackboard on a weekly basis. The gradebook in MML will not show your current weighted grade. The grades in MML will only show the individual grades you earn on your homework and quizzes. The overall grade in MML is not weighted. Therefore, it will not match your overall grade in Blackboard. MML is a just a hub for your homework and quiz grades. It does not include your test grades.

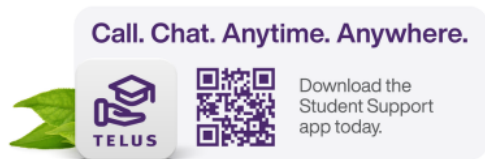
