COURSE DESCRIPTION

An introduction to the methods and analysis of data from psychological studies. Fundamental concepts and techniques of both descriptive and inferential statistics and their application to psychological research.

Prerequisites: PSYC 2301 and MATH 1314.

COURSE NOTE

This course is part of a sequence of courses. Further, this course lays the foundation for all other Psychology Courses you may take. It is a challenging, but incredibly important course. Truly learn the material, and all the classes after this one will be easier.

I will strive to be available to aid your learning process by providing several ways to contact me:

- **Email:** Please only use official university e-mail and include the course, section, and full name in the subject line. Please do not use Blackboard messages. The email noted above is my primary and preferred point of contact outside of the classroom.

Especially when it comes to clarifying assignment instructions and/or submission requirements.

In all communications, please be professional in your tone and specific in your message (i.e., avoid informal correspondence styles like text messaging which lack appropriate punctuation and capitalization). Your correspondence **MUST** include the information specified above. If you send an email without sufficient information, I likely will not reply or may reply asking for clarification about your inquiry (this can result in an unnecessary delay). Please begin a new email thread instead of responding to older emails if you are beginning a new conversation unrelated to the previous email (this helps minimize confusion caused by chain replies).

- **Office Hours:** I will be available in my office (STEM 249B) to meet during office hours (see above) or by appointment. Office hours are dedicated to interacting with and providing students assistance regarding coursework. An appointment is not necessary to attend these hours, but interactions are limited to a first come, first served basis. If there is a specific assignment/materials or topic you want to discuss, providing advance notice will allow me to have these resources ready. If students cannot meet during these times, an alternative time can be requested via email, and I will do my best to try to accommodate students accordingly. For discussions involving more personal and/or sensitive information, some form of advance notice is recommended.

ASSESSMENT & EVALUATION

All assignments, with the exception of some in-class work, will be administered from and turned into Blackboard. No paper copies will be accepted unless otherwise noted. Late work will not be accepted without a university-approved excuse and/or advance notice with instructor approval. Additionally, you are expected to complete all work independently (see Academic Integrity section for more details on independent work).

The following descriptions are intentionally brief. Detailed instructions will be available in class and through Blackboard throughout the semester. Each assignment will have a specific set of instructions students will be required to follow.

- **Homework Assignments – 20 points.** Ten homework assignments will be administered throughout the semester, each worth 20 points. The topic/format of the homework assignment will depend on the content for the week.
- **Exams – 100 points.** Four exams will be administered, each worth 100 points. Exam 1, Exam 2, and Exam 3 will be non-cumulative. Exam 4 (i.e., the final exam) will be cumulative. The exams will have questions that will vary in format (e.g., multiple choice, fill-in-the-blank). Exams will only be offered on the dates and times listed in the course schedule. There are no make-up opportunities for the exams once the deadline has passed. The only exceptions to this policy are valid excuses for absences (see Missed/Late Assignment Policy). The exam with the lowest grade will be dropped.
- **In-Class Assignments – 25 points.** Three in-class assignments will be randomly administered throughout the semester, each worth 25 points. One in-class assignment will be dropped. The topic/format of the in-class assignment will depend on the class lecture for the day.
- **Final Paper – 200 points.** You will be required to complete a final paper that will consist of writing the methods, results, and discussion sections for an experiment in APA format. Detailed instructions for the final paper (e.g., format, length) and rubric will be posted on Blackboard.
- **Extra Credit Opportunity – 5 points.** You will be given a review for all your exams. Submissions of a completed review worksheet before the review session, will receive 5 points.

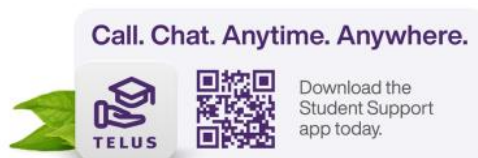
COUNSELING/MENTAL HEALTH RESOURCES

FINANCIAL AID AND VERIFICATION OF ATTENDANCE

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. THE SIX-DROP RULE

▪ Students' Rights
