**Course Description:** This course is designed to allow the Biology Program to add a specialized course that fits the needs and requirements of a cohort of graduate students but will not be a permanent elective course topic. Special topics courses allow the students and faculty to explore current new topics in the scientific field, to focus specialized training on particular biological subfields, and/or provide specialized training in a unique subfield/topic that is currently not an elective. Prerequisite: biology graduate student status.

**Learning Objectives and Course Format:** This course is to familiarize the incoming cohort of graduate students with the specialized knowledge necessary to pursue participation in research efforts with graduate faculty members (both thesis and non-thesis students). The format of the course will allow content-based learning to establish a basic background for understanding research in which faculty and their students are contributing to what is presently known in a particular field of study. Depending on the faculty member, this may be quite specific. We will have several graduate faculty members contributing to the course (Table 1). Each faculty member will have three 75 minute class periods to teach content and to introduce their research agenda. Note that any method of teaching/learning may be used by the faculty members. Some may lecture, while others may require readings followed by discussions, etc. It is up to the faculty member (see below).

**Course Requirements:**

**Attendance.** Whether the faculty member presents a face-to-face course portion, or uses an online mode, synchronous attendance is mandatory. This allows a real time interaction between the faculty member and the graduate students. Furthermore, listening to the questions or requests for clarification generated by fellow graduate students in real time will also potentially allow for a vigorous discussion focused on the unknowns being explored by faculty members and their students.

**There is no textbook requirement for this course;** however, faculty may require you to read scientific (usually primary) literature to prepare for a presentation or discussion concerning original research. Each faculty member will provide the class with any required reading materials a week in advance of when it needed (typically posted to BB).

**Course Grading:** Course grades are earned from the combined assessments from each faculty member. The last day for a given faculty member will be the assessment day for what was learned from the activities over the two to three prior meetings. Each faculty member will provide an assessment worth 60 points. Thus, one can earn a total of 420 points in total for the course, and grades will be based on the percentage of points earned from the total (90% = A, 80% = B, 70% = C, 60% = D, etc.).

Exam questions will be in one of the following formats: fill in the blank, matching, multiple choice, calculations, or short answer, or essay. Exams will be based on lectures, readings, and discussions.

Faculty may hold assessments on the third meeting day or may have the students complete a take-home assessment that can be submitted in person or via Turnitin (BB course page).

Table 1. Teaching Schedule for BIOL 5370 (Fall 2024). Note that graduate students often seek research information informally with graduate faculty and are given assignments to read and then discuss research potential with the faculty member. Thus, if you are seeking a research mentor, you are not limited to the faculty teaching in this class this semester.

**Policies:**

**1) No make-up exams will be given without approval before a scheduled exam. Unexcused, missed exams, receive a score of zero.**

2) Missed, *excused exams* (e.g. for scientific conference attendance or other university activities, etc.) must be negotiated and approved by the faculty member involved before the absence. Excused absences due to medical conditions must be documented.

3) Use of electronic devices (phones, computers, etc.) for note taking is permissible, but discouraged. Research on learning has shown that listening and paraphrasing is more efficient for learning than stenography, i.e. trying to transcript the professor.

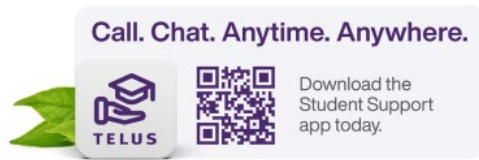

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
