Course Description

History 1301 is a United States history survey course. It begins with an examination of pre-Columbian societies and early encounters between Old World and New World peoples. It continues chronologically and topically through the Colonial Period, Revolutionary Era, Early Republic, Antebellum Period, and Civil War. Among other topics, this course devotes special attention to the role of markets and profit motives in historical change; the revolutionary Atlantic world as essential context for the American Revolution and resistance to slavery and waged labor, and the revolutionary and broadly transformative nature of the Civil War. Accordingly, this course strives to hone a foundational understanding of early U.S. history as well as an awareness of some of the broad processes and patterns which animate the past and intersect with the present.

Learning Outcomes

Upon successful completion of this course, students will be able to:

1. Critically analyze primary and secondary source evidence to construct an argument.
2. Develop analytical writing skills.
3. Analyze and discuss the major historical, social, political, economic, cultural, and global forces that mark this period of United States history.
4. Analyze and discuss how North America was imagined, and what it meant, to a diversity of people during different moment of early American history.
5. Analyze and discuss North America/United States as a part of global history.

Instructor

I am Mindi Sitterud-McCluskey. I teach history courses at Texas A&M San Antonio, the University of the Incarnate Word, and Northwest Vista College. I earned my doctorate degree at the University of Arizona and my master's degree at Boston College, with specialties in economic history, labor and working-class studies, slavery, social movements, transnational

migrations, and the human experience of American foreign policy. The courses I teach reflect these specialties and my interest in the lives of ordinary people.

Required Materials

- You do not need to purchase a textbook for this course. All course readings and multimedia assignments will be provided in our Blackboard course shell.
- Students should arrive to class with a means by which to take notes, be it paper/pen or a laptop.

Hybrid Format and Expectations

As a hybrid course, this class meets once a week on campus. Attendance and participation in discussion and learning activities is expected. Students are also expected to complete assigned learning activities and assessments beyond the classroom. Some of these assignments will constitute the typical homework regime for a 1301 course. Others are intended to provide instruction and learning that would otherwise occur during a second weekly meeting (most non-hybrid 16-week courses meet twice a week).

Learning and Assessments

Lecture Guides: Lecture guides are provided to facilitate notetaking during classroom sessions. These lecture guides do not need to be submitted. Completed lecture guides should prove beneficial, however, to the completion of quizzes and writing assignments. A well-done set of lecture guides can also earn a student extra credit at the end of the semester.

Hybrid/ Homework Assignments: Weekly learning activities are assigned as part of the typical History 1301 homework regime as well as to take the place of a second weekly class meeting. These learning activities include recorded lessons, readings, primary resource analyses, and multimedia assignments such as documentary film and podcasts. The questions which accompany these assignments are to be completed and submitted through Blackboard before the start of class on the due date provided (typically the following Thursday).

Quizzes: Students are expected to complete biweekly multiple choice quizzes covering material addressed in class and as part of the hybrid/homework assignments. These quizzes are located in Blackboard and must be submitted before the beginning of class on the due date provided (typically Fridays). They are untimed and students are encouraged to use their completed lecture guides and hybrid/homework assignments.

Essay Assignments: There are three assigned essays. Each essay assignment is centered upon a particular theme emphasized by the course. Students are expected to draw upon course materials, class discussion and analytical thought to create and support a thesis in response to the essay

topic. The essay with the lowest score will be dropped from the grade calculation at the end of the semester.

Classroom Policies

Participation and Courtesy: Class discussion is an important part of this course, and we will not always agree. All points of view are welcome, as long as they are informed (meaning, you have done the required assignments for class) and are not deliberately discriminatory or demeaning of other students. As we engage in the material and in conversation with each other, we must remember to do so respectfully and constructively.

Electronic Devices: Cell phones and earbuds should be muted and put away at the beginning of class. Laptops are permitted as long as they are being used for class purposes. Violations of these policies will result in becoming dismissed from class and losing attendance points.

Attendance: Students are expected to attend all on-campus sessions. The material discussed and presented in class is a vital part of the course, needed to complete additional learning activities and assessments. In cases where attendance is not possible, students can have up to 2 class absences excused by completing and submitting the lecture guide which accompanies the lecture/s missed. Please speak with professor if a valid excuse can be provided for more than two absences (serious illness, military, etc.).

Late Work: Due to in-class discussion needs, no more than half credit will be awarded for late quizzes and homework assignments. Exceptions can be made under certain circumstances (please speak with professor)

AI and Plagiarism: All written work must be the product of student engagement with learning activities and analytical processes. Due to the distinct thematic approach taken by this course and assessment guidelines which require students to clearly draw upon course material when answering questions and writing essays, AI tools and keyword internet searches will likely prove insufficient to assessment demands. Moreover, assignment submissions found to be AI generated

or lifted from another source will be denied credit and might put the student at risk of university protocols for plagiarism, including dismissal.

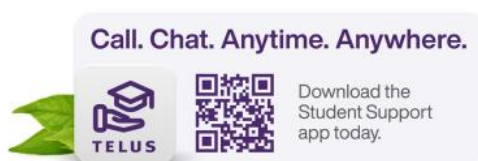

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Option 1 - No Use of Generative AI Permitted

Option 2 – Use of Generative AI Permitted Under Some Circumstances or With Explicit Permission

There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Option 3 – Broader Use of Generative AI Permitted Within Guidelines

Use of artificial intelligence (AI) tools, including ChatGPT, is permitted in this course for students who wish to use them. To adhere to our scholarly values, students must cite any AI-generated material that informed their work (this includes in-text citations and/or use of quotations, and in your reference list). Using an AI tool to generate content without proper attribution qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Option 4 – Customized Policy Generative AI Policy
