**Catalog Course Description:**

This course provides an introduction to the principles and applications of microeconomics in addressing commercial business challenges. Emphasizing quantitative and analytical methods, it is designed to strengthen the essential problem-solving abilities of business students within practical business contexts. Topics covered include supply and demand, price theory, competition, market structures, market failure, the role of government, and other pertinent economic issues.

Prerequisite(s): Admission to the 11-month MBA cohort-based program.

**Course Objectives:**

The objective of this course is to strengthen students' comprehension of fundamental economic concepts, including demand, supply, production, and costs. Additionally, it introduces advanced tools such as regression analysis and game theory. Students will learn to distinguish various market structures and utilize the associated concepts and tools to make optimal managerial decisions.

**Prerequisites:**

Admission to the 11-month MBA cohort-based program.

**Student Learning Outcomes:**

After successfully completing this course, students will be able to:

1. Explain how specific economic events or government policies can impact the demand, supply,

- and market equilibrium of a product;
2. Use regression analysis in Excel to estimate a product's demand function;
  3. Recognize different market structures and determine the profit-maximizing price and quantity for a firm within each context;
  4. Employ game theory to anticipate the outcomes of interactions between firms;
  5. Identify business practices that contravene US antitrust laws.

**Required Materials:**

- **Textbook:** *Economics of Managerial Decisions by Blair and Rush (Optional)*
- **Blackboard:** Connect to <http://tamusa.blackboard.com>. You will have access to slides, multimedia material and other supplementary material on Blackboard.
- **Time Expectation for coursework:** You are expected to dedicate 2-4 hours per week outside of lectures for this course. Depending on individual backgrounds, some students may need additional time. Expect increased study hours during assignment or exam periods.

**Course Requirements every student must fulfill in order to succeed in course:**

1. Students are advised to regularly check their emails and the Announcements section on Blackboard.
2. Students must stay up-to-date with all quizzes and examinations.
3. Students are encouraged to ask questions and communicate with the instructor in class, online, offline, or during office hours.

**Grading Policy:** The final course grade will be determined by your performance in quizzes and exams, using the following weights:

**Examinations and Quizzes:** In-class quizzes are brief assessments designed to gauge your attention to and comprehension of the fundamental aspects of topics covered that day or the preceding day. If you're not satisfied with your end-of-class quiz or final exam grade, you are permitted to retake it at home. The quiz grade will be calculated as 0.25 multiplied by the in-class attempt score, plus 0.75 multiplied by the at-home score.

**Make up and Late Assignment/exam/quiz policy:** Late submissions and make-up exams are not allowed unless the student provides verifiable evidence of a legitimate emergency situation.

**Class conduct and civility code:** Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions in class and online, including the following:

1. Attendance may be taken at the beginning or the end of the class.
2. It is the students' responsibility to obtain and be able to use the required materials and software for this class.

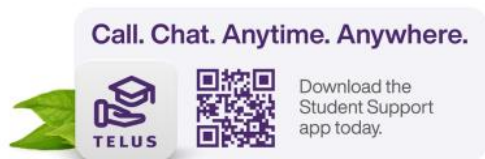

**Financial Aid and Verification of Attendance:** According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
