Course Description and Material

Catalog Description: Systems of linear equations, matrices, determinants, vector spaces, eigenvectors, eigenvalues, orthogonality, linear transformations and their representations by matrices, and applications.

Prerequisite: Math 2313 and Math 2113, or Math 2413; all prerequisites require a grade of "C" or higher.

Required Textbook: Linear Algebra and Its Applications by David Lay, Steven Lay, and Judi McDonald (the 6th edition), with MyMathLab. Pearson Publishing with ISBN-13: 9780135851159 **NOTE:** Please find the instructions on the Blackboard for the registration.

Student Learner Objectives: The course explores the fundamental concepts and principles of linear algebra with applications, and upon completion of this course, you will:

- Demonstrate an understanding and working knowledge of matrices and vectors. •
- Formulate and solve problems requiring the application of matrices, linear transformations and • their properties.
- Exhibit a basic proficiency in determining and explaining linear algebraic structures and their • analytic and/or geometric interpretation.
- Demonstrate a basic understanding of the underlying principles of vector spaces.
- Write clearly about linear algebra concepts to include definitions, counterexamples and simple • proofs.
- Apply linear algebra to model basic geometric, biological or physical problems. •

List of Topics: Topics to be covered include but are not limited to the following:

- 1. Linear Equations in Linear Algebra (Sections 1.1 ~ 1.5, 1.7, 1.8)
- 2. Matrix Algebra (Sections 2.1 ~ 2.3)
- 3. Determinants (Sections 3.1 ~ 3.3)
- 4. Vector Spaces (Sections $4.1 \sim 4.3$)
- 5. Eigenvalues and Eigenvectors (Sections $5.1 \sim 5.4$)
- 6. Orthogonality and Least Squares (Selected Sections $6.1 \sim 6.6$)

The instructor reserves the right to modify/update the topics as appropriate.

NOTE: This class meets twice a week. Aside from the three hours that you spend in class each week, you should devote at least another 4~6 hours to studying on your own: reading the book and my lecture notes, working out your homework assignments, and solving some extra related problems for practice etc. You are responsible for any and all materials/topics discussed in this class.

Active Learning and Inquiry Based Learning: This course implements active learning and inquiry-based learning approaches throughout, and the students are strongly encouraged to preview the teaching materials and be aware of many in-class participation and self/group study activities.

Course Expectations and Requirements

Class Attendance: You are expected to attend classes as scheduled and be prepared to participate in discussions, in-class exercises, and problem presentations. Attendance is taken in each class and will contribute to your final grade. Each student is allowed up to 3 absences for the duration of this course, and any further absence may affect their final grade. In addition, if an unavoidable situation prevents you from being on time or if you must leave early, **please minimize class interruption**.

Examinations: There will be four exams during the entire semester. Students are expected to take all four exams at regularly scheduled class time. Exceptions for a legitimate reason may be granted by and must be approved by the instructor beforehand. You will need to notify (or under certain special circumstances have someone else to notify) me formally that you will miss, or have missed an exam and provide a reason, with the accompanying documents supporting that, for your absence within 24 hours of the scheduled exam date. I can be notified by e-mail, or in person with a written notice. Contact me beforehand to make the necessary arrangement if you know in advance that you will be unable to take an exam at the regular class time. Students who fail to follow the prescribed procedure will receive a **GRADE OF ZERO** on the missed exam.

The schedules will be announced at least a week ahead of time when the time comes both in Blackboard and via email. They can be either in-class, 75-minutes exams, taken home projects, and/or hybrid. Test 1 covers Chapter 1 (only selected important topics). Test 2 covers Chapters 2~3 (only selected important topics). Test 3 covers Chapters 4~5 (only selected important topics). Final exam covers Chapters 1~6 (only selected important topics).

NOTE: Graphic TI-83 or higher calculators, cell phones, laptops, i-pads, kindles, and any other electronic or mobile devices will absolutely be **NOT** allowed during the tests/final exam. Once found, your tests/final exam will receive a **GRADE OF ZERO**. If this happened in a recursive manner, then the instructor would report to the university as an academic dishonesty issue.

Assignments: All homework assignments will be completed online in MyMathLab (MML). Read the announcements on Blackboard for all instructions and all due dates are listed in MML. If you cannot finish all the questions, then please try your best to finish as many problems as possible. Do not wait until the last day to start your homework assignments. Work on the problems daily. The homework assignments may be attempted multiple times to increase your homework grade. **NO** late homework assignments will be accepted, **NOR** make-up allowed.

You may have group/team discussions on homework assignment problems. However, you must write up the solutions on your own and truly understand the mathematics/algorithms involved. Be mindful of your academic integrity.

Electronic Devices: Cell phones, laptops, i-pads, kindles, and any other electronic devices must be turned off and put away during class. Anyone who is observed text messaging or using an electronic device during class will be given a warning, and as a further action that person will be asked to drop this class.

Presentations/Debates: Students will be expected to participate in class by presenting/debating problems emphasizing the most recently covered topics that are related to and complementing HWs.

Evaluation of Student Performance: Every student's grade will be based entirely on his/her performance. Students will not compete against one another for grades.
