# **Course Description**

History 1302 is a United States history survey course. It begins with an examination of Reconstruction and post-Civil War developments, including westward expansion, industrial capitalist expansion and the working-class struggle. It continues chronologically and topically through the Gilded Age and Progressive Era, US overseas expansion, World War I, the Gret Depression, World War II, the Cold War and rise of the National Security State and the Civil Rights Movements. This course is designed to provide students with a foundational and critical understanding of United States history during the timeframe addressed. It also aims to promote an awareness of the cause-and-effect nature of historical developments and hone understandings essential to making sense of the present and formulating constructive responses to the challenges of our time.

# **Learning Outcomes**

Upon successful completion of this course, students will be able to:

- 1. Critically analyze primary and secondary source evidence to construct an argument.
- 2. Develop analytical writing skills.
- 3. Analyze and discuss the major historical, social, political, economic, cultural, and global forces that mark this period of United States history.
- 4. Analyze and discuss how North America was imagined, and what it meant, to a diversity of people during different moment of early American history.
- 5. Analyze and discuss North America/United States as a part of global history.

# **Course Readings**

You do not need to purchase a book for this course. All course readings and assignments will be provided in our Blackboard course shell.

#### Instructor

I am Mindi Sitterud-McCluskey. I teach history courses at Texas A&M San Antonio, the University of the Incarnate Word, and Northwest Vista College. I earned my doctorate degree at the University of Arizona and my master's degree at Boston College, with specialties in economic history, labor and working-class studies, slavery, social movements, transnational migrations, and the human experience of American foreign policy. The courses I teach reflect these specialties and my interest in the lives of ordinary people.

# **Learning and Assessments**

#### In-Class Lectures & Lecture Guides

Core historical content and context are conveyed through interactive powerpoint lectures. Students are expected to attend class and take part in note-taking and discussion. To facilitate note-taking, lecture guides are provided (uploaded in Blackboard). These lecture guides are not graded assignments, but they can be used during quizzes.

#### Weekly Homework Assignments

Each week, students will be expected to complete a homework assignment. Most of these assignments take the form of documentary films, primary resources, readings and, for hybrid course, recorded lessons. Students are required to complete & submit comprehension questions associated with these homework assignments. As with the lecture guides, comprehension question worksheets can be used while taking quizzes.

### Quizzes

Three unit quizzes assess learning and engagement regarding both in-class lectures & weekly homework assignments. Each quiz is to be completed outside class via Blackboard. No more than half credit will be awarded for late quizzes. It is recommended that students use completed lecture guides & homework comprehension questions to facilitate their quiz performance.

#### Essays

Each of the three course units includes an essay topic option. Students are required to choose <u>two</u> of these topic options and compose an essay for each during the semester according to due dates specified in the course schedule. These essays are not research papers. Rather, students will be primarily assessed according to a demonstrated ability to draw upon & critically analyze specific course materials and historical episodes addressed as part of the course curricula. General requirements:

- 4-5 pages
- Typed, double-spaced
- 11-12 pt font

### **Classroom Policies**

<u>Participation and Courtesy</u>: Class discussion is an important part of this course, and we will not always agree. All points of view are welcome, as long as they are informed (meaning, you have done the required assignments for class) and are not deliberately discriminatory or demeaning of other students. As we engage in the material and in conversation with each other, we must remember to do so respectfully and constructively.

<u>Electronic Devises</u>: Cell phones and earbuds should be muted and put away at the beginning of class. Laptops are permitted as long as they are being used for class purposes. Violations of these policies will result in becoming dismissed from class and losing attendance points.

Attendance: Students are expected to attend all on-campus sessions. The material discussed and presented in class is a vital part of the course, needed to complete additional learning activities and assessments. In cases where attendance is not possible, students can have up to 3 class absences excused by completing and submitting the lecture guide which accompanies the lecture/s missed. Please speak with professor if a valid excuse can be provided for more than three absences (serious illness, military, etc.).

<u>Late Work</u>: Due to in-class discussion needs, no more than half credit will be awarded for late quizzes and homework assignments. Exceptions can be made under certain circumstances (please speak with professor)

AI and Plagiarism: All written work must be the product of student engagement with learning activities and analytical processes. Due to the distinct, thematic approach taken by this course and assessment requirements which stipulate that course materials be clearly drawn upon, AI tools and keyword internet searches will likely prove counterproductive and insufficient. Moreover, assignment submissions found to be AI generated or lifted from another source will be denied credit and might put the student at risk of university protocols for plagiarism, including dismissal.

## Option 1 - No Use of Generative AI Permitted

# Option 2 – Use of Generative AI Permitted Under Some Circumstances or With Explicit Permission

There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

# **Option 3 – Broader Use of Generative AI Permitted Within Guidelines**

Use of artificial intelligence (AI) tools, including ChatGPT, is permitted in this course for students who wish to use them. To adhere to our scholarly values, students must cite any AI-generated material that informed their work (this includes in-text citations and/or use of quotations, and in your reference list). Using an AI tool to generate content without proper attribution qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

## **Option 4 – Customized Policy Generative AI Policy**

Faculty may create a customized policy that is unique for a specific course with consultation from the department chair. Faculty are encouraged to view *Texas A&M University's Generative AI Syllabus Statement Considerations* when preparing a customized AI policy.
