## COURSE DESCRIPTION

Laboratory to reinforce and apply concepts introduced in <u>PSYC 3304</u> Psychology of Learning lecture. **Prerequisites:** <u>PSYC 2301</u> and <u>2388</u>. **Corequisites:** <u>PSYC 3304</u>.

#### **COURSE OBJECTIVES**

As a result of taking this course, you will be able to:

- Understand various learning theories.
- Apply research fundamentals to concepts learned in Psychology of Learning Lecture.
- Explore and extend ideas learned in Psychology of Learning Lecture.

#### GRADES

Students MUST attend the lab to earn grades on lab assignments. Some assignments are due at the end of class, and some assignments will be submitted through blackboard within 24 hours of the lab meeting. Some instructions/rubrics will be available on blackboard, but some are available ONLY during the lab meeting.

There are 14 labs. Twelve of the labs are worth 10 points each. Two of the labs are online and are worth 5 points each. Your nine highest 10-point lab grades and the two online 5-point lab grades will count towards your final grade. This means that the three lowest 10-point lab grades will be dropped. This generous policy is meant to allow you to maintain a good grade if you are struggling with some lab concepts. Further, it is meant to help you if there are times that you have emergency situations and are unable to come to class. It is important to consider that ALL the information in the lab has been created to support you in the lecture.

Several Labs will continue over several lab meetings. If you miss a portion of a multi-class period lab, you may need to complete the lab by yourself (most of the long-term labs involve group work). While the points for a missed lab cannot be made-up, you may need to complete the portion that you missed in order to continue with the other parts of the lab. Try to avoid missing any lab classes so that you can get your full educational experience.

Your final grade in this class will be calculated as a simple average: your points earned on your nine highest 10-point lab grades plus points earned on the two 5-point labs divided by the maximum number of points you could have earned. In this class you can earn up to a total of 100 points. Grade Cutoffs: A = 90, B = 80, C = 70, D = 60, F < 60.

All written work should be academic quality submitted as per the assignment in 7<sup>th</sup> edition APA format in order to have the opportunity to earn full credit.

#### LATE WORK

Since labs are completed in-class, late work will not be permitted. However, if you miss a lab it can be one of the grades dropped. I

If you arrive late or are not truly present during the lab meeting, you may receive a 0 on the assignment for the day (at the discretion of the instructor or lab manager).

Note: In the past, some students have taken advantage of the drops early in the semester, and then later in the semester they find themselves in the difficult situation of having to miss due to an emergency and being out of low grades that can be dropped. Do not let this happen to you! Do not abuse the drop policy!

#### WITHDRAWAL POLICY

Any withdrawals after the last day for an automatic "W" date established by the university will receive the grade of "F" if the student is failing or a W if they are passing.
