Course Description and Materials

Catalog Description: The course encompasses the study of limits, continuity, and derivatives of algebraic, trigonometric and transcendental functions and related applications to include maximizing or minimizing a function and rate of change problems. The course also introduces the definite integral, the Fundamental Theorem of Calculus and application to calculation of areas. Curve sketching and graphing tools will be utilized in exploring these concepts.

Math 2113 and Math 2313 help students develop Critical Thinking, Communication, and Empirical and Quantitative Skills by focusing on student understanding of the calculus concepts to include recognizing, identifying, solving, analyzing, and explaining appropriately model applicable real-world situations.

Prerequisite: Math 2312 Pre-Calculus with a grade of "C" or higher, or equivalent, or permission by the department.

Required Textbook: Essential Calculus, Early Transcendentals by James Stewart (2nd edition) Cengage with ISBN-13: 978-1-133-11228-0. E-text will be used through Cengage WebAssign Platform. Purchasing a hard copy of the textbook is optional.

Other Materials: Scientific calculators can be used for in-class activities.

Student Learner Objectives: Upon completion of this course, students will be able to:

- Develop solutions for tangent and area problems using the concepts of limits, derivatives, and integrals.
- Interpret and draw graphs of algebraic and transcendental functions considering limits, continuity, and differentiability at a point.
- Determine and explain whether a function is continuous and/or differentiable at a point using limits.
- Apply differentiation rules to differentiate algebraic and transcendental functions.

- Identify and apply appropriate calculus concepts and techniques to provide mathematical models of real-world situations, and to determine and explain solutions to applied problems.
- Evaluate definite integrals using the Fundamental Theorem of Calculus.
- Recognize and articulate the relationship between derivatives and integrals using the Fundamental Theorem of Calculus.

Active Learning and Inquiry Based Learning: This course implements active learning and inquiry-based learning approaches throughout, and the students are strongly encouraged to preview the teaching materials and be aware of many class participation and self/peer study activities.

Course Expectations and Requirements

Class Attendance: Students are expected to attend classes as scheduled and be prepared to participate in discussions, in-class exercises, quizzes and problem presentation. Class attendance during class. If we meet at Zoom, then attendance is taken in the Zoom Chatroom by typing "Hi, Burak Aksoylu is present." You are strongly encouraged to attend all classes. I give out a lot of extra credit for class participation which will be directly added to your score as a bonus.

Midterm Exams: There will be two in-class exams during the semester. In case you miss an exam or find out that you will miss an exam, you should contact me either in person or by e-mail, at least one week in advance of the exam for non-emergency cases or within 24-hrs of the scheduled exam date for emergency cases. Any missed exam counts as a 0 unless the student has a valid documented excuse and contacts me as soon as possible after the excuse for missing the test arises. Examples of valid documented excuses are sickness documented with a doctor's note, death in the family documented with a copy of the death notice, attending university-sponsored events with a Dean's excuse, etc. Minor headaches or attending sports events (without Dean's excuse) are not examples of emergency situations.

Final Exam: In order to pass this class students must take a final exam scheduled during Finals Week. Final exams cannot be rescheduled or missed (for dire and unforeseen medical or family emergencies, students must consult with me).

Homework/Quizzes: Homework and quizzes will be assigned through Cengage WebAssign. You will be solving an abundant number of required problems as well as optional problems for extra credit. Quizzes will be directly from the homework. I strongly encourage you to do the homework regularly. There will be 4 quizzes and your lowest score will be dropped. There will not be make up for Quiz. Quizzes typically will have two parts: **in-class (80% weight)** and **take home (20% weight)**.

Calculators: Basic scientific calculators (non-graphing, non-programmable) are permitted on quizzes and exams. A TI-30XIIS scientific calculator is highly recommended. Cell phones, graphing calculators, and online math utilities are not allowed on quizzes or exams. When appropriate, more advanced calculators and software may be used on homework assignments and during class discussion.

Grading Policy

The final course grade is calculated as follows:

Attendance/Participation: 5%; Homework: 10%; Quizzes: 20%; Exams: 40% (20% each); Final Exam: 25%.

Tips for Studying: The main characteristic of the mathematic course is the fact that all the topics are linked to each other, so that every newly introduced concept is built upon old ones. The most common reason for difficulty in this course is failure to study consistently. You must study this course consistently. You are developing a skill; **no one would expect to become good at tennis if s/he only played once a month.** In order to succeed, the student should do all the following:

- Read the material in the text before class. Attend the lecture and take notes. During the lectures relevant examples are discussed.
- Practice solving many problems in the e-text even not assigned ones.
- Do *all* assigned homework and attempt *all* questions.
- Seek help. Visit your instructor during office hours. Ask about poorly understood points as soon as possible.
- Exam Preparation. Redo all the homework and quiz problems and questions that I solved in the class.
- Work neatly. Make sure you show all work. Answers/solutions given with no explanation may receive little or no credit! During the exams, if you have time, check your work.
- Keep track of your grade on BlackBoard or Cengage WebAssign.

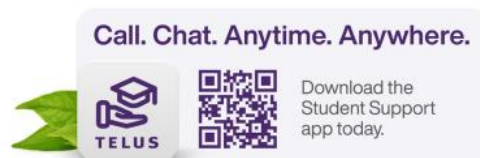
