Course Description

British Literature explores the evolution of the English language across literary periods and genres, from the Middle Ages to the 21st century. By comparing texts from the British Isles, its former colonies, and Commonwealth nations, we will examine how linguistics, poetics, culture, art, history, and religion shaped poetry, prose, fiction, and drama written in English.

Course Goals

Book Clubs

This semester, you and your Brit Lit peers will work together in small groups called “Book Clubs.” While you will spend a lot of time by yourself reading, researching, and writing about literature, you cannot wholly succeed as a literary reader, writer, and scholar on your own. You need an audience who cares just as much as you do about literature and literary research to discuss difficult passages, read drafts of your papers, and offer constructive feedback.

Attendance

You are absent if you are not present for class and late if you arrive after attendance has been taken. You must communicate the circumstances with me **in advance** to be excused for an absence or late arrival. Your success and development as a writer depend on your active participation within your writing community. Consistent attendance is crucial and is graded. You will lose 2 points for an unexcused late arrival and 5 points for an unexcused absence.

Plagiarism

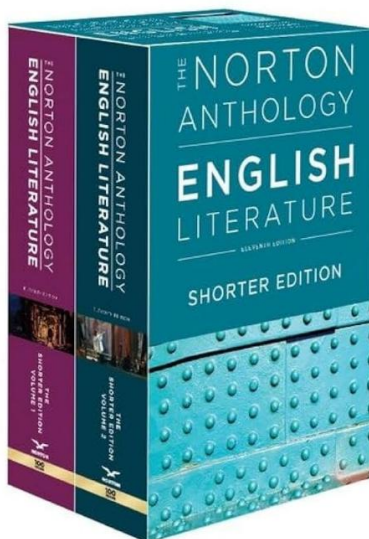
Plagiarism is defined as the intentional use of another's "language, ideas, or original (not common-knowledge) material" without acknowledgement ("[Defining and Avoiding Plagiarism](#)"). I expect you to generate your own content this semester. While generative AI tools such as ChatGPT can help you brainstorm, generate ideas, and learn basic information about a topic, they can also provide biased or incorrect information and produce stilted writing which lacks human imagination. Furthermore, relying on generative AI to write content for you prevents you from developing as a university-level writer and critical thinker. If you plagiarize or include any AI-generated content in an assignment, you will receive a permanent zero on that assignment without the opportunity for revision.

Respect

I am committed to fostering a respectful classroom environment in which different backgrounds and perspectives are acknowledged. While working with classmates and instructors, you will respectfully listen to others' experiences and perspectives, share your own experiences and perspectives, and value the opportunity to learn from each other. Demonstrating respect for those different from you not only prepares you for success in the classroom, but also prepares you for success as citizens and professionals. This course is reading-intensive (50+ pages assigned per week), and will also include a lot of writing and research. Please be prepared each class to discuss assigned readings, but do not be afraid to voice different and unique perspectives on literary texts and their meanings. To succeed in this course, it is crucial that you read all assigned texts, develop original ideas about those texts and their authors, attend class, take detailed notes, engage with your peers during discussions and workshops, write with integrity and inspiration, and ask for help!

I grade assignments each week with written feedback. You can check your total grade at any time in Blackboard. Please email me or visit my office during walk-in student hours to request an extension in advance, or a revision. Late assignments lose 1 point per day late.

Student Services and Support

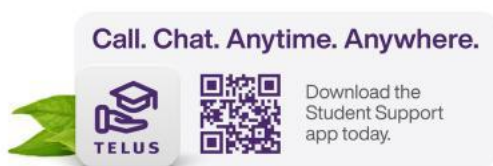

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Any student receiving federal financial aid who does not attend by the census date will have their financial aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester, a Care report will be submitted, and you will possibly be dropped from the class. Your financial aid may have to be recalculated and a portion of your federal aid may have to be returned to the DoE. Please note that any student who stops attending any time during the semester may also need to return a portion of their federal aid.

Writing, Language, and Digital Composing Center: The Writing, Language, and Digital Composing Center supports graduate and undergraduate students in all three colleges as well as faculty and staff. Tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. Our language tutors support students enrolled in Spanish courses and students composing in Spanish for any assignment. The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built.
