Welcome to the course! If you approach this course with an interest in learning about courts and criminal procedure and remain focused on the goal of learning, you may well find this to be a fascinating course. Before we begin, please read this syllabus which provides a roadmap of the semester, outlines course policies and expectations, and provides some tips for improving your chances of succeeding in this course. This syllabus will also serve as a reference throughout the semester which you can consult to answer many of your questions and to guide you towards resources which may be of assistance. By remaining enrolled in this course (choosing not to drop the course), you are agreeing to abide by all course policies set forth in this syllabus.

### **Course Description**

This course is the study of criminal law including application of definitions, statutory elements, defenses and penalties using Texas statutes, the Model Penal Code, and case law. The course also analyzes the philosophical and historical development of criminal law and criminal culpability.

## Course Requirements and Expectations

### *Class Attendance and Participation*

*This is a hybrid course. We will meet on Wednesdays from 7:00-8:15 pm in the Science & Technology Bldg. Also, students are expected to log in and complete work each week. Students are expected to have read the assigned material(s) prior to completing assignments including, taking exams, and quizzes.*

**Class Attendance:** Showing up and participating in our face-to face portion of this course is worth 10% of your overall final course grade.

### **Video Case Assignments** (100 points each)

Located in Cengage MindTap, the link for each **Video Case** Assignments is located under Course Content for each week. You will click the link within that week's Module to take you to the MindTap website. It is important that prior to attempting your **Video Case** Assignments, that you read the corresponding chapter first. This will provide the information that will help you be successful on your **Video Case** Assignment. You will need to watch the short video in its entirety prior to attempting to answer the questions covering the video. **Video Case** Assignments are not timed. You are allowed two attempts and your highest score is recorded. **Video case** assignments are worth up to 100 pts each. **Video case** assignments constitute 10% of your overall final course grade.

**"You Decide" Scenarios:** After you finish reading your Chapter and complete your Video Case Assignment, you will be prepared to complete the **"You Decide"** assignment for each Chapter. Like the Video Case assignment, you will have a short scenario to watch or read and then complete the assignment. **"You Decide"** Assignments also allow for two attempts, are not timed, and worth up to 100 pts each. **"You Decide"** assignments constitute 10% of your overall final course grade.

### **Chapter Exams** (100 points each)

In this course, you are required to complete **Chapter Quizzes** (called Chapter Exams each week. These **Chapter Quizzes** are located within MindTap and should be accessed under each week's Unit. Each **Chapter Exam** will cover material from that particular chapters text readings and other Mindtap information such as "You Decide" and Video Case assignments. There are 25 multiple choice questions per **Chapter Exam**. Unlike Video Cases and "You Decide" assignments, **Chapter Exams** are

timed for 60 minutes. You only have one attempt on **Chapter Exams** and they are worth up to 100 pts each. **Chapter Exams** constitute 30% of your overall final course grade.

**Mid-Term Exam (100 points)**

In this class, you are required to complete a comprehensive **Mid-Term Exam**. The **Mid-Term Exam** will come from the Chapter readings, quizzes, and other material found under each week's unit as well as what we cover in class up through Week 7. The **Mid-Term Exam** will be timed (90 minutes) and you will have 50 questions worth 2 points each for a total of up to 100 pts. It will be taken here within our Blackboard course. The **Mid-Term Exam** counts 20% of your overall Final Course grade.

**Final Exam (100 points)**

In this class, you are required to complete a comprehensive **Final Exam**. The **Final Exam** will cover all material after the Mid-Term. The **Final Exam** will be timed (90 minutes) and you will have 50 questions worth 2 points each for a total of up to 100 pts. It will be taken here within our Blackboard course. The **Final Exam** counts 20% of your overall Final Course grade.

**Financial Aid and Verification of Attendance:** According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
