**Catalog Course Description:** Development of a framework for the analysis of financial statements: study of the firm's competitive environment and business strategy, critical review of accounting quality, assessment of financial condition, and evaluation of future prospects.

**Course Objectives:** The objectives of this course are: (1) to understand financial statements under GAAP, (2) understanding managerial incentives with regards to the financial statements, and (3) how to translate accounting information into firm value. We reinforce the accounting concepts and then extend them to interpreting firm value. This course will help you better understand financial statements and which components are relevant to firm valuation and firm creditworthiness.

**Prerequisites:** Admission to MPA program.

**Student Learning Outcomes:**

After successful completion of the course, the student will:

- (a) Understand the information content of financial statements under GAAP.
- (b) Understand the effect of managerial incentives on the quality of financial statements.
- (c) Understand the relation between accounting information and firm value.
- (d) Understand how to conduct time-series and cross-sectional analysis of accounting information in financial statements.

**AACSB Assessment:** The College of Business is in the process of applying for AACSB accreditation. The materials from this course may be used for assessing such program level outcomes, and hence students must follow the necessary rigor to ensure mastery and retention of the above course outcomes.

- **Time Expectation for coursework:** You are expected to spend 3-6 hours per week for the course. Based on the background, some student may require more time. Time spent may be longer when assignment/exams are due.

***Course Requirements every student must fulfill in order to succeed in course:***

1. Students should check the Course Calendar, Announcements, and Emails on a regular basis.
2. Students should keep current with all course assignments, quizzes, and examinations.
3. If the course uses remote proctoring for exams, students must schedule their exam early in the semester.
4. Students should ask questions and communicate with the instructor in-person/online.
5. For all classwork, exams, quizzes etc., if a student is completing it off-campus, then they are responsible for availability of internet connectivity. Extensions will not be granted for lack of availability of internet connections.

**Grading Policy:** The final course grade will be based on your performance on the quizzes, exams, assignments and attendance using the following weights:

The final letter grades will be assigned as follows: Above 90% ⇒ A; 80 – 89.99% ⇒ B; 70 – 79.99% ⇒ C; 60 – 69.99% ⇒ D; Below 60% ⇒ F.

This course has a requirement of a grade of C as a minimal grade for satisfactory completion of this course. **The instructor reserves the right to adjust the student's final grade based on the overall performance.**

**Examinations:** There will be two mandatory mid-term exams and a mandatory final exam (as per university schedule). The exams/quizzes will consist of conceptual multiple-choice questions, problem solving questions, and short essay questions. The exam/quiz materials will come from lecture notes, the text, and class discussions. Questions will emphasize understanding and applications of concepts and topics covered in class. **Missing an exam will result in a grade of zero for that exam and may result in a fail grade in the course.**

**Proctored Exams:** Examinations in this class may/will be administered using secure online testing services. Details regarding proctored test sign up and administration will be provided at least 2 weeks prior to the exam.

**Assignments:** Problem solving homework will be assigned for most of the chapters. The purpose of homework is to apply the information learned during class. Each problem-solving homework assignment will be available for two weeks to complete it. Students can refer to the homework schedule to find out exact dates for each assignment.

**Experiential Learning Assignment:** Students will find the Accounting Standards updates from Financial Accounting Standards Boards (FASB) website and write a paper regarding the expected effect of the Accounting rule changes.

Students will use financial statements of S&P 500 companies to write analyst reports by applying the analyzing skills and knowledge that they learn from the course.

**Make up and Late Assignment/exam/quiz policy:** As a general rule, no make-ups or late submissions will be offered/accepted for any missed assignments/exams/quizzes. Late submissions or make-ups may be accepted/administered only in extraordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation within a few days of the missed assignment/quiz/exam.

**Generative Artificial Intelligence (AI):** ACCT5318 assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

**Course Drop Policy:** You may drop the course on or before **Nov. 14, 2025** with an automatic grade of W. If you wish to drop the class after that date, you will receive either W (if you have satisfactory record so far) or F. The last date to drop a course, or withdraw from the University

is **Nov. 25, 2025**. If you wish to drop the class, you must submit the necessary paperwork to the proper authority.

The course covers a lot of material, and most students find at least some parts of it difficult. The course is intensive and challenging, and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.

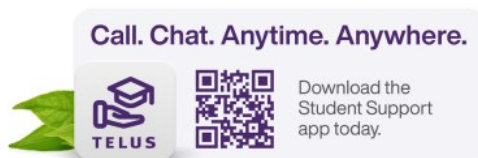
