Course Catalog Description:

American rebellion, the Revolution, the Confederation period, the Constitution, the Federalist, Jeffersonian, and Jacksonian eras, ending with the Mexican American War and the Compromise of 1850.

Student Learner Outcomes:

Upon completion of this course, the student will be able to:

1. Analyze the major events and problems of the American Revolution, Early Republic, and Jacksonian Era.
2. Identify and analyze primary and secondary sources related to the American Revolution, Early Republic, and Jacksonian Era.
3. Analyze historians' research and arguments concerning the American Revolution, Early Republic, and Jacksonian Era.
4. Interpret the various influences on the lives of Americans in the American Revolution, Early Republic, and Jacksonian Era.

Assessment of Student Learner Outcomes

The student learner outcomes 1, 3, and 4 will be assessed through tests, while outcomes 2 and 3 will be assessed through performance on the essays.

Basic Components of the Course:

- 1) Lectures, Notes, and Readings
- 2) Book Essays: Two essays
- 3) One in-class essay
- 4) Tests: Three Essay Tests
- 5) Participation: Attendance, in-class discussions, and in-class writing assignments

Testing and Grading:

Grades are assigned on a ten-point scale: A- 90-100%, B- 80-89%, C-70-79%, D-60-69%; F- 59% and below

The final grade will be based on the following formula-

The three exams and three essays will all count for 15% each, and the participation grade is 10% of the final grade.

No Extra Credit will be offered. I do not add points onto final grades even if a student is close to another grade.

Graded work should be returned within 2 weeks if not sooner.

Attendance:

Regular attendance is required. I take attendance at the beginning of class, so if you enter the class significantly late, you will be counted absent. If you leave class early, you will be counted absent as well. As much of the course work happens in class, missing four classes or more will result in a loss of one letter grade (-10 points) for this class. All students (whether present or absent) are responsible for all announcements made in class and all assignments given in class because it is sometimes necessary to make changes to the syllabus.

Make-ups:

Exams can only be made up in the case of a documented emergency, **and they must be scheduled and completed within one week of the missed exam.** Book essays are due by the date and time marked on the syllabus. If submitted late, book essays will accrue late penalties of five points per day late. The penalty will be applied to essays submitted more than 15 minutes late but won't accrue the next five points until 24 hours later. **Late essays will be accepted up to five days after the due date only.** All essays are due on blackboard through a turnitin assignment. I will not accept papers that have not been submitted through turnitin in blackboard. Keep your submission receipt in case there is a problem. If you have an emergency and cannot submit your paper on time, you must talk to me right away and provide documentation of the emergency. Otherwise, your paper grade will receive the penalty. You also need to use a program that turnitin accepts (like Microsoft Word).

Academic Misconduct Policy

Students at Texas A&M University-San Antonio are expected to adhere to the highest standards of academic honesty and integrity. Academic misconduct for which a student is subject to penalty includes cheating, plagiarism, fabrication, multiple submissions, misrepresentation of academic records, facilitating academic dishonesty, unfair advantage, violating known safety requirements and ethical misconduct. the appearance of such behavior. If you are ever unclear whether a specific act might constitute academic misconduct, please contact your instructor for an assessment of the situation.

All student term papers and other written assignments are subject to analysis by anti-plagiarism software.

In my class, plagiarism or cheating on a test will result in a 0 for that assignment and reporting of the violation.

Turnitin: You will submit your papers to the turnitin assignment in blackboard. Once submitted, you will get a report with a percentage. Lower is better, and zero is best. But, the number doesn't tell the whole story. No matter how low your number is, click on the color next to the

number (green, yellow, red) to see your actual results. Take a look at what is not original. If the matches are all citations, then you are fine. If it is a common phrase, it is OK (i.e., “the peculiar institution”). If a whole sentence comes up, you need to look at that. If a sentence comes up, minus 3 random words, you need to look at that too. All work must be your own. Changing a few words does not make it your own. You can submit your paper and make changes until the due date. When you resubmit, it can take one or two days for your originality report to be created. Turnitin now checks for AI as well.

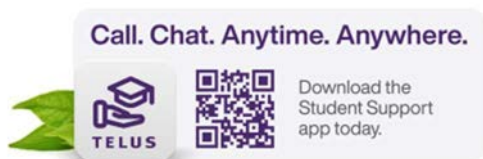

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Writing, Language, and Digital Composing Center: The Writing, Language, and Digital Composing Center supports graduate and undergraduate students in all three colleges as well as faculty and staff. Tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. Students' Rights

2. Students' Responsibilities

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.

2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, Student Code of Conduct, on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.

Option 2 – Use of Generative AI Permitted Under Some Circumstances or With Explicit Permission

There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.
