#### **Catalog Description and Prerequisites:**

## 1307. General Biology II – Biology of Organisms. 3 (3-0)

This course provides an overview of the diversity of life, the evolutionary relationships among major groups of organisms, and the structural/functional characteristics of these organisms. Topics emphasized will include the study of life at the organismal, population, and community level including form, function, reproduction, taxonomy, systematics, ecology and evolutionary history of biodiversity. This course is designed for students majoring in science fields. This course meets the standards for the Life and Physical Sciences category of courses under the core curriculum. Students majoring or minoring in Biology cannot use placement exams (e.g. CLEP) to fulfill this course requirement. Students whose degree program has this course as a listed requirement must earn a 'C' to be considered passing. Prerequisite: A passing grade of 'C' or better in BIOL 1306 and BIOL 1106. Co-requisite for students majoring or minoring in biology: BIOL 1107 – General Biology II Laboratory.

#### **Learning Objectives:**

Upon completion of this course, the student will be able to:

- 1. Students will develop critical thinking skills, communication skills, and Empirical and Quantitative skills. Students will learn to work as a team.
- 2. Student will gain an appreciation for the diversity of life on Earth.
- 3. Students will be able to compare and contrast how different organisms carry out similar life functions.
- 4. Students will understand what homologous structures are.
- 5. Students will be able to interpret basic cladograms that show evolutionary relatedness
- 6. Students will understand the basic principles of evolution.
- 7. Students will understand the basic principles of population, community, and ecosystem ecology. Students will also be able to evaluate if a scientific question is best answered via experiments at the population, community, or ecosystem level.
- 8. Student will be able to critically assess content and illustrate its broader meaning to the public.

1. Competencies will be demonstrated on homework, quizzes, activities/projects, and exams. Exams may have a combination of essay, listing, matching, multiple choice, and true/false questions. All types may not

be included on each exam.

- 2. A student must master 70% of the competencies in order to receive credit for the course. A student demonstrating 90% or more knowledge of all competencies will receive an A in the course.
- 3. <u>All Connect homework and quiz</u> submissions will be online. There will be several activities that are conducted during class time and/or outside with either in-class and/or online submissions.
- 4. All exams will be Face-to-Face during scheduled class time. Please see the syllabus schedule.
- 5. All exams and assignments will be graded on a point system.
- 6. All exams and assignments are scheduled on the tentative syllabus schedule and Blackboard Calendar.
- 7. You may turn assignments in ahead of the deadline, <u>but if you miss the deadline</u>, <u>your assignment will be</u> assigned a **zero**. **I DO NOT ACCEPT LATE WORK.**
- 8. There is the *potential* for extra credit opportunities for this class. These will be announced during class time so be sure to attend class regular because not all can be made up.

\*\*HINTS FOR SUCCESS. Complete assignments and submit them in on time. <u>Do not wait until the night before</u> to study for exam or complete assignment. <u>All assessments are provided with plenty of completion time</u>.

### **Lecture Exams (<u>Face-to-Face</u>):**

- 1. You will be given four (4) Lecture Exams & a Cumulative Final Exam.
- 2. Your <u>Lecture Exams</u> will consist of approximately 40-50 questions in the format stated in Grading Scheme #1 above. Exams 1 & 2 are worth 100 points each. Exams 3 & 4 are worth 75 points each (mini-exams).
  - Exams will be **given during the scheduled class time**; Feedback will be limited and provided during office hours or by appointment.
  - Exams must be taken on the scheduled class date/time in syllabus & Blackboard.
- 3. Your <u>Cumulative Final Exam</u> contains material from the entire semester. This exam must be taken (it <u>cannot</u> be dropped or replaced).
  - Your final exam will be in a format similar to your lecture exams.
  - Your final exam will consist of 100 questions and worth 200 points.
  - Final Exam <u>must be taken</u> by the <u>due date</u> in the syllabus and University Final Exam Calendar and Blackboard during the scheduled time.
- 4. Exams must be taken when scheduled.
  - You may make up an exam **only if** 
    - you contact me within **one day (24-hours)** of the scheduled exam
    - your absence is one approved by college policies (illness, death in the family, other immediate-family emergencies). **Documentation will be required.**
    - Again if I do not hear from you within 24 hours of the scheduled exam, you have forfeited the right to make up the exam.

#### **Connect Homework (online):**

- One (1) out of the <u>nine</u> (9) Connect homework will be dropped and the remaining <u>eight</u> (8) will be included for this portion of your course grade.
- Each chapter(s) will have a set of Homework Questions. You will have 2 attempts to answer these questions and each attempt will have an unlimited time frame so you will have plenty of time to read the textbook in order to find the answers. This is the only assessment in which I highly encourage you to find the answers to the questions in your textbook.



- All Connect homework assignments will be available beginning the first day of the course unit so you may work ahead; however, each one has a Due Date corresponding with the exam schedule, so complete these first, and then use them to study for your quizzes and exams.
- Chapter Homework assignments <u>cannot</u> be made up.

#### **Connect Quizzes (online):**

- You will complete a series of Quizzes (a group of chapters included on an exam) covering the material from the chapters you will study this semester.
- All quizzes will be available beginning the first day of the course unit; however, <u>each quiz is timed (20 minutes for 20 questions) with 2 attempts</u>; therefore, it is recommended to complete the corresponding homework(s) first then take the quiz for each exam.
- One (1) out of the seven (7) quizzes will be dropped and the <u>remaining 6 quizzes</u> will be included for this portion of your course grade.
- Quizzes will cover the main ideas for each exam.
- Quizzes cannot be made up.

#### iNaturalist Tour of Texas Ecology Portfolio (worth 50 points total; Part 1 = 25 pts & Part 2 = 25 pts)

- During the semester, you will contribute to our class iNaturalist Project by documenting biodiversity in your local environment. You will complete three rounds of iNat observations. From your observations, you will select one focal species (plant or animal) to showcase in a portfolio that connects your field observations to course concepts. This will be *showcased virtually and peer reviewed midway (Part 1)* and on the last day of class (Part 2) (see schedule below). Worksheets will be provided throughout the semester to 'kick-start' the research process as well as use for lecture exam reviews. These worksheets may be graded and included as part of The Environment and You Assignments category or extra credit (see below section).
- A grading rubric and more details will be provided during Units 2 and 3. The goal of this portfolio activity is to begin applying these general biology concepts that you are learning about to your own personal environment as well as showcasing students' creativity skills.

#### The Environment and You Assignments (7 out of 8):

- 1. Class Assignments (varies online & face-to-face):
  - Throughout the semester, you will complete a series of hands-on activities corresponding with course topics. Additional details will be provided on Blackboard and during class time.

#### Therefore, please come to class because each assignment type is different!

- Class assignments have corresponding due dates & <u>cannot</u> be made up. Please see tentative schedule. <u>Therefore</u>, <u>please come to class! Not all assignments can be made up or may be conducted only during class time</u>.
- \*Some activities are conducted outside with online submissions; therefore, please plan accordingly regarding weather and time management. \*

#### 2. iNaturalist (free app!)

• You will becoming familiar with a few tools/apps the public has access to learn about the



- organisms all around you. These tools are part of a field called Community Science that biologists can use to help gather various types of data.
- There will be <a href="mailto:the">three (3)</a> small assignments (scavenger hunts) that utilize iNaturalist tool that you will work on throughout the semester. <a href="mailto:Assignment details are provided on Blackboard and during class time and each has an associated due date!">assignment details are provided on Blackboard and during class time and each has an associated due date!</a>

#### 3. Real-world Class Discussions

- You will be encouraged to apply the concepts we discuss during class and 'think outside of the box' as they pertain to real-world issues occurring today. Throughout the semester and <u>corresponding</u> with each course unit (time between exams), you will conduct an online class discussion on different environmental issues/topics that we discuss <u>during the current course unit</u>.
  - There will be a total **four (4)** class discussions for this portion of your grade.
  - O You will <u>submit via Blackboard</u> a short response about the current environmental issue/topic that is posted in the Discussion Board. <u>Each topic is associated with the current unit(e.g.</u> Discussion #1 will be relevant to evolution in our world today).
  - The format of the discussion prompt may vary by unit. Instructions will be provided with each prompt.
  - O Part 1 consists of your response to the discussion topic in approximately 5-7 sentences. You can be as detailed and creative as you would like; I will provide some creative ideas for you in the discussion prompt to encourage this. *Part 1 will be worth 5 points*.
  - Part 2 consists of you replying to at least one other student's response in approximately 3-5 sentences. I am hoping this is a fun assignment to encourage you to 'think outside of the box' on issues that natural resources scientists are currently studying and monitoring. I also hope this assignment allows everyone to communicate with each other outside of the classroom! *Part 2 will be worth 5 points*.
  - o Remember to use good spelling, grammar, and be respectful!

## **Attendance / Participation:**

<u>This is a face-to-face course; therefore, coming to class is important.</u> I will <u>randomly</u> take attendance during some lecture days, which can consist of <u>roll call</u>, activity participation, question of the day submissions, etc. Therefore, if you miss class and attendance is taken, attendance points cannot be made up unless you provide university approved documentation (per the syllabus). If you also miss class, you will be responsible for obtaining missed information from your classmates and/or reading the textbook.

## **Makeup Policies:**

Due to the nature of this course and the fact that exams, quizzes, and homework/assignments are given plenty notice and/or *are open for more than one week*, make-up opportunities will only be allowed for:

- a. Hospitalization (evidence required),
- b. Hospitalization of an immediate family for which you are the primary caretaker (evidence required), or

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving



federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.
