**COURSE DESCRIPTION AND OBJECTIVES**

Analysis and design techniques required for implementing medium to large-scale computer information systems. Development of requirements for personnel, software and equipment for typical applications.

**Course Objectives:** Students will learn about information system concepts, hardware and software systems components, the basics of systems operation, and the ethical use of information systems. Students will gain a greater understanding of information systems.

**Student Learning Outcomes:**

Measurable Course Objectives are outcomes, and students are expected to achieve by the end of the course. Upon successful completion of this course, candidates will be able to demonstrate their competence in and their ability to:

1. Describe different lifecycle models and explain the contributions of systems analysis and design within them.
2. Discuss various approaches to systems analysis and design and explain their strengths and weaknesses.
3. Evaluate the tools and techniques of systems analysis and design that may be used in a given context.
4. Use appropriate methods and techniques to produce an analysis of a given scenario.
5. Use appropriate methods and techniques to produce a system design for a given scenario.
6. Provide suitable documentation for systems analysis and design activities.

**AACSB Assessment:**

The College of Business is AACSB accredited. As part of this accreditation, students will be assessed on program level outcomes based on course outcomes from various courses. The materials from this course may be used for assessing such program level outcomes, and hence students must follow the necessary rigor to ensure mastery of the above course outcomes.

## Required Materials:

- **Time:** You are expected to spend 4-8 hours per week for the course. Based on the background, some student may require more time. Time spent may be longer when assignment/exams are due.

### *Course Requirements every student must fulfill in order to succeed in course:*

**Examinations and Quizzes:** There will be quizzes, tests and a mandatory final exam (as per university schedule). Non-submission of an exam will result in a grade of zero for that exam and may result in a fail grade in the course. The exams may consist of conceptual multiple-choice questions, problem-solving questions, and short essay questions. The exam materials will come from lecture notes, the text, and class discussions. Questions will emphasize understanding and applications of concepts and topics covered in class.

**Assignments/ Research papers:** There will be several assignments and projects during the course. Individual assignment statements and due dates will be posted through Blackboard. The research papers will provide an opportunity for an in-depth investigation of specific topics. Additional instructions and requirements for the research papers and projects will be provided as separate handouts at the course website.

**Project / Milestones:** Additional instructions and requirements for the project will be provided as separate handouts at the course website. There will be one mandatory project during the course. Assignment statements and due dates will be posted through Blackboard. There are four mandatory milestones for the project. Considerable points will be taken off for not following these requirements. Additional instructions and requirements for the final presentation will be provided as separate handouts at the course website.

**Make up and Late Assignment policy:**

Exams: As a general rule, make-ups or late submissions will **NOT** be offered or accepted for any missed exams/quizzes. If you miss an exam for a valid documented excuse, then the grade for the missed exam will be replaced with a grade equivalent to the percentage score in the final exam. If you miss the final exam, you must contact the instructor within 24 hours and provide valid proof of your special situation.

Assignments: All assignments must be (100%) complete and (100%) accurate before submitted. No incomplete/incorrect submissions will be accepted. Late submissions will be assessed a grade reduction penalty. The grade reduction penalty will be specified in the instructions for the assignment. The grade reduction penalty for late assignments will be waived only if you have a valid **documented** extra-ordinary circumstance such as an excused official university activity, a severe illness, or a dire emergency. Attendance is not a direct component of your semester grade, but a situation may affect your grade if it causes you to miss assignments. E-mail me if you have a valid excuse but **do not submit any documentation until requested.**

**Class attendance and Participation:** A vital part of every student's education is regular attendance of class meetings. Any absences tend to lower the quality of a student's work, and frequent or persistent absences may result in a failing grade. You are responsible for any missed instruction or assignments. Classroom participation includes pop quizzes related to computer assignments, discussion of chapters, cases and additional materials. E-mail communication, phone calls and office visits are not part of classroom participation. The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important. Reading the assigned chapter(s) and having some familiarity with them will be very useful for understanding recorded lectures. Each student will be expected to spend enough time in the preparation of the assignments.

**Class conduct and civility code:** Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions in class and online, including the following:

1. It is the students' responsibility to obtain and be able to use the required materials and software for this class.
2. Student must retain copies of all assignments and graded work for verification purposes. Keep copies of all computer files and e-mails.
3. If you will not be able to complete this course, dropping from this class is your responsibility.
4. For any questions about the exams and assignments, a student should contact the instructor, before the day they are due, so the instructor may have enough time to provide feedback.

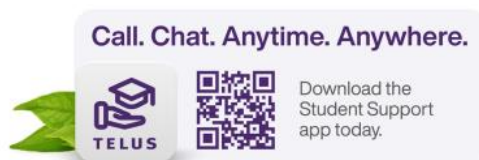

**Financial Aid and Verification of Attendance:** According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
