Course Description:

This course teaches students to apply the principles of communication theory in the presentational speaking context with an emphasis on audience/communication analysis, adapting to diverse audiences, and self-awareness. This course meets the standards for the Component Area Option category under the core curriculum.

By the end of the course, every student should be able to:

- 1. Demonstrate self-perception through recognizing diverse perspectives and understanding the ethical implications of communication.
- 2. Cultivate active listening skills.
- 3. Design intentional messages by practicing audience analysis.
- 4. Research, develop, and deliver extemporaneous informative and persuasive speeches with effective verbal and nonverbal messages.
- 5. Develop critical thinking skills through practicing effective group communication.

All written assignments should be submitted digitally via Blackboard. Emailed copies of assignments are not considered submitted, unless accompanied by an explanation of technical difficulties (see *Technical Issues with Blackboard* below).

In-Class Assignments

Throughout the semester, students will participate in up to 12 In-Class Activities (ICAs). Each student is required to participate in 10 ICA; meaning you will not be penalized for missing up to 2 ICA. Please note that you can only earn up to 100 points from ICA and completing additional ICA will not increase your grade. ICA cannot be made up (except for excused absences).

Quizzes

Students will complete 10 at-home, open-book quizzes throughout the semester. The first 9 quizzes are worth 10 points each and focus on 2 topics each. The 10th quiz is worth 30 points and is cumulative.

Reflection Paper

Students will complete a 2-page paper reflecting on your standpoint, anxiety with public speaking, and your ethical approach to communication.

Informational Video Speech

Students will select a topic and create a 4-5-minute Informational Speech video. Students can select almost any topic to conduct the speech over, so long as the topic is school/workplace appropriate. In this video, the student must be "embodied" as defined by the textbook.

Persuasive Group Speech

Students will develop and conduct a speech encouraging audience members to donate to a non-profit organization (NPO). Students will need to conduct research on their non-profits to inform their audience on the mission and function of the NPO and its effectiveness at completing these goals.

Groups will be selected in classes 4 weeks before the speech.

(a) Speech

Students will conduct a 10-11-minute speech that persuades their peers to donate to a non-profit organization of their choice. Each member of the group must participate and speak up during the speech.

(b) Evaluation

Students will provide self- and peer-assessments evaluating the contribution of each member of the group to the overall project.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

COURSE POLICIES:

Communications: I will post class updates, extra credit opportunities, and/or additional materials as announcements on Blackboard and/or to your university email. Check Blackboard and read your email regularly (at least 2-3 times per week) because you are responsible for this information, just as you are responsible for information in class.

When you email me: (1) re-read the syllabus or assignment sheet first, (2) put the course title and section number in the subject line, (3) allow 24 hours (not including weekends) for me to respond to your email. Please remember that email is a form of professional communication, so use proper spelling, grammar, and

formatting in all your correspondence with me (and all other university officials).

Classroom Civility: We want to build a classroom climate that is comfortable for everyone. In a communication class, it is especially important that we (1) display respect for all members of the classroom, including the instructor and students; (2) pay attention to and participate in all class sessions and discussions; (3) avoid unnecessary disruption during class time (e.g., having private conversations, checking email/social media, doing work for other classes, making/receiving cell phone calls, text messaging, etc.); and (4) avoid racist, sexist, homophobic, or other negative language that may unnecessarily exclude members of our campus and classroom. This is not an exhaustive list of behaviors; rather, they represent the minimal standards that help make the classroom a productive learning environment for all concerned.

Technical Issues with Blackboard: If I am informed by the university if Blackboard has gone offline when an assignment is due, then I will notify you of the new due date. Barring this, you are responsible for turning in your classwork on time. If you are having issues posting or submitting, first troubleshoot: 1) check your internet connection, 2) try restarting/changing your browser (do not use Safari), then 3) use a different computer. If this doesn't fix your problem, screenshot your issue and email it to me with the assignment (this will only be allowed once per issue), then seek ITS for more help.

Students who miss an assignment deadline due to an excused absence should contact the instructor within 24 hours of missing the assignment to make arrangements for an adjusted deadline. Students will be given an extension of no less than 24 hours but no more than 1 week based on the situation.

Challenging a Grade: I am always willing to discuss your grades with you, but I will not do so during class time. To challenge a grade, you must make an appointment to meet me *after 24 hours of receiving the assignment and within one week* of the assignment being returned to you. When we meet, you must present your concerns in writing and attach the graded assignment. Please note that a challenge may result in grades being raised or lowered.

Note on Final Grade: Students (particularly graduating seniors) who "need" this course to graduate or "need" a particular grade in this course should work especially hard to ensure that they receive a passing grade. There will be no opportunities for students to re-take exams or re-complete assignments in order to raise their grade. It is the student's responsibility to ensure that he or she receives a passing final grade (or whatever grade they desire) by working diligently and responsibly throughout the semester.

Syllabus as Contract: This document is not only to inform you of general course information, assignments, point values and policies, but additionally serves a contract between the instructor and you the student. You, the student, agree to all of the above by remaining in the course. The instructor agrees not the change assignments, point values, or policies, UNLESS it is determined that a change is necessary for the course to function AND student are notified of the change via email with the updated syllabus being posted to Blackboard.
