WHAT THIS CLASS ACTUALLY IS

Catalog Description – Legal and ethical limitations and responsibilities of the mass media, relationship and interaction between broadcaster, governmental regulatory agencies and the public.

Course Objectives – By the end of this course, students should be able to do each of the following:

- 1. Understand and apply principles and laws relating to the freedom of speech and of the press.
- 2. Conduct legal research and evaluate information by methods appropriate to the professions, audiences, and purposes that mass communication targets/serves.
- 3. Think critically, creatively, and independently about legal problems and solutions unique to the various mass communication industries.
- 4. Analyze and apply ethical theories to real-world media scenarios.

GETTING/KEEPING IN TOUCH

The best ways to get in touch with me are (1) talk to me in person during office hours and (2) through email (listed at the top of the page). DO NOT (repeat, DO NOT) try to get in touch with me through Blackboard Messaging. I don't ever check that, so let's just avoid that altogether.

REQUIRED TEXT

- Mass Media Law, by Clay Calvert, Dan V. Kozlowski, & Derigan Silver, twenty-second edition; published by McGraw-Hill. You will be accessing this e-book and completing your reading assignments through Connect (McGraw-Hill's online learning platform). This means that when you purchase your book, you'll be getting not only the book itself but also access to Connect. The book is available both at the University bookstore and directly <u>from the publisher</u> (which I've been told is the less expensive option).
- Media Ethics at Work: True Stories from Young Professionals, by Lee Anne Peck and Guy Reel (editors), second edition; published by CQ Press. There's no Connect component for this text, so feel free to get either a physical copy or an e-book copy.

HOW THIS CLASS IS GOING TO WORK

The class is divided into three units – Intro/Basics, Defamation, and Other (Invasion of Privacy, Accessing Records/Meetings, and Protecting News Sources).

Within each unit, we'll spend about a week covering each chapter (there are exceptions – some chapters will get three days rather than two because they're more complicated).

For each chapter that we read, students will need to complete a SmartBook assignment (this is an adaptive reading assignment), plus any other assignment that I give related to the course content. Assignments are discussed in more detail in the next section of this syllabus.

GRADING

Readings (SmartBook Assignments)

- 10% of total grade
- Administered through Connect (which is accessible through Blackboard)
- Due by 11:59 PM two days after we finish discussing a chapter (either Thursday or Saturday)
- No late submissions accepted

Scenarios

- 50% of total grade
- One per chapter for Chapters 3-10
- Due by 11:59 PM two days after we finish discussing chapter
- Late submissions accepted for up to one week after due date, with a 10% penalty per day

Case Studies

- 20% of total grade
- Four over the course of the semester
- Due by 11:59 PM the day before discussion of the next chapter starts (either Monday or Wednesday)
- Late submissions accepted for up to one week after due date, with a 10% penalty per day

Quizzes

- 20% of total grade
- 3 quizzes (1 per unit) will be given
- Administered through Blackboard
- Due by 11:59 PM on the date specified in the course calendar
- No late submissions accepted

For your Scenario and Case Study assignments, you will be allowed to use <u>Grammarly for Education</u> in order to guide you in the writing process (but NOT as a substitute for doing the actual writing yourself). I will require you to submit each of these assignments as a Google Doc, so that I can look at your edit history and make sure you didn't (a) get some robot to do the writing for you and then (b) use the copy and paste functions to pretend like you did the writing yourself. You will also need to submit a list of the

prompts that you used in your Grammarly interactions. Any violation of any of these terms on any assignment will result in a grade of zero for that assignment.

In the interest of maximizing your chances of success in this course, I would advise you very strongly to prioritize your various commitments so that you can submit all of your assigned work on time. Zeroes have a destructive impact on your overall grade.

CLASS POLICIES

Attendance: Attendance is mandatory for this class and all others in the Communication program. If you do miss a class, it is your responsibility to check Blackboard, find out about any assignments/due dates/handouts/announcements that were covered in the class(es) you missed, and make up any work you missed.

Absences: Missing the equivalent of two weeks of class due to unexcused absences will reduce your final grade for the course by one full letter grade. Missing the equivalent of three weeks of class due to unexcused absences means that you cannot pass the course. Should this happen, you will (a) need to drop the course or (b) receive a failing grade. In a course like this one, six absences is the equivalent of missing three weeks of class.

- An excused absence is one in which you miss class either for a required activity or because of illness (excessive excused absences can also result in you not passing the class).
- An unexcused absence is any other absence.

Arriving on time: This course begins at 2 pm every Monday and Wednesday. If you arrive after attendance has been recorded, then you will be counted late for that class session.

Accumulated lates: Three lates equals one absence. These add up more quickly than you'd think.

Classroom distractions: If you're doing something in class that has nothing to do with what we're covering that day, then I'm likely to be distracted by what you're doing. If you distract me, I will ask you as politely as possible to stop. If you persist in the distracting behavior, then you will be removed from class for the remainder of that day's class.

Use of Generative AI: Your instructor assumes that all work submitted by COMM 4317 students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.
