Course Description:

This course is designed to introduce students to critical issues of criminal justice. Current debates in criminology will be discussed.

Course Learning Objectives:

Upon successful completion of the course, students should be able to:

- 1. Think critically about modern issues within the field.
- 2. Conduct a policy analysis.
- 3. Identity key literature to support debates in criminology and criminal justice.

Many of the elements of this course will help you improve your critical thinking and problem-solving skills. These may be carried over into non-research components of your life. Upon successful completion of this course, you will have an increased understanding of several historical and current issues in criminology and criminal justice. The main topics we will be covering will be 1) crime control strategies, 2) juvenile justice reforms, 3) white collar crime, 4) cybercrime and technology impacts on the system, 5) bail reform, and 6) human trafficking.

Course Materials:

There is no required text for this course. All reading materials (research articles) will be provided via Blackboard.

Class Format:

This course will consist of reading research articles, policy labs, and a final policy analysis paper. You are expected to complete each of these assignments by the given deadlines.

Assignments & Learning Activities

1. <u>Perusall Reading Assignments</u>: Every week, you will be assigned approximately 4-5 articles to read via Perusall. The point of using Perusall is to allow me to see your thought process as you read and, more importantly, allow you to discuss the readings with your classmates. See complete instructions on Blackboard.

- 2. Policy Lab Fishbowls: Each week three to four students will identify a real policy related to the topic that we are discussing to critically assess. The steps for these are as follow: 1) choose a local, state, or federal policy related to each week's issue. This can be a policy you identify on your own, or it can be one discussed in the readings from the week. 2) Read the assigned reading for the week. You can gear your annotations to identifying key findings, critiques, and implications for this part of the course. 3) Follow the policy lab worksheet to analyze the policy. This helps you to identify the key strategies needed to analyze a policy for the final paper. Those who did not complete the policy worksheet will provide peer-reviews of the policy analysis. More specific instructions will be provided on Blackboard and the Perusall assignments.
- 3. Policy Analysis Paper: The final paper will involve identifying a policy you would like to analyze. The paper must use at least 5 peer-reviewed sources, and the analysis should be supported with peer-reviewed journal articles. Papers should be approximately 1,250 words, but no more than 1,500 words, in length; it is anticipated that papers will be approximately 5 to 7 double-spaced, typed pages in length (in 12-point font with one-inch margins). If your paper exceeds this length, you will receive a 0 for any sections not covered in the first 7 pages (title pages and references do not count against the page length). This will be a five-part, scaffolded assignment. Each assignment is named in the schedule for the week it is due, and instructions for each assignment will be available on Blackboard.

Grading Information:

Assignments will be submitted via Blackboard or Perusall. I anticipate grading and returning assignments within two weeks of their submission. If you have questions about the assignment, please email me no later than Friday at 5:00 PM before the assignment deadline. I will not be answering emails over the weekend.

If you have questions about your grade on any assignment, you have ONE WEEK after the grade is posted in which to come to me to question your grade (that is, to ask for point changes based on justifiable criteria— except for the last week, because grades are due within a few days, in which case you have 48 hours). After that time period, the grade stands (even if you did not check the grade until after that time period).

Should you raise serious questions about how something was graded, I reserve the right to regrade your entire assignment (meaning your grade may go up or down). I recommend waiting 24 hours after a grade is posted to email with a question; often, initial emails are reactionary, and waiting 24 hours allows sufficient time to process. If you do choose to email me regarding a grade within 24 hours of its posting, be sure to use professional language in your email.

I do not bump grades or provide extra credit to raise grades at the end of the semester because I believe in being as fair and transparent in grading as possible. Please ensure you do your best work on each assignment and ask for help as needed throughout the semester.

As a rule, I do not speak with parents regarding grades or assignments. As college students, you are adults, and capable of managing your own academic affairs. If you have questions about your grade, please email me yourself or come to office hours to discuss things.

Course Policies

Attendance & Census Day Requirements: For this online, asynchronous course, attendance will be measured by completing all assignments from Week 1, since we do not meet in person.

Email: You will need to be looking for communications from me through your TAMUSA email. I regularly send messages out to my courses to keep them updated with course. If you are not reading these or checking your school email, you will miss out on vital information for the course.

When you need to contact me, you **must** use an email through Outlook. My email address is at the top of this syllabus. I do not see messages from Blackboard until much later; please do not use that platform feature. Your emails should be written formally and include an appropriate subject line that includes your course number and section, and a brief description about the subject of your email (e.g., CRIM 5302-600: Conflict with Due Date). The email itself must include a proper greeting, a fully constructed body of the message using proper grammar and sentence structure, and a formal sign off. Without these features, I will not respond to your email.

Make-up and Late Work Policy: If you miss a submission deadline because of participation in university-sanctioned activities, arrangements to make-up missed work can be made by contacting the course instructor. Makeup work requires documentation. If you experience technological difficulties that prohibit you from completing assignments, you must document this via a screenshot or another comparable method.

All assignments are to be submitted on the due date. In cases of planned excused absences, late work will be accepted by an agreed upon alternate due date. Late work will otherwise not be accepted.

Academic Honesty: Students are expected to adhere to university policies regarding academic honesty. If you violate these policies, you will be reported and subject to the appropriate sanction which may include expulsion from the University.

Citation Style –Because this is a criminology and criminal justice course, students are required to use the citation style and format of the American Psychological Association (APA). It is acceptable to cite legal materials (cases, statutes, regulations, etc.) in accordance with the style specified in The Bluebook.

Avoiding Plagiarism – Some students truly do not understand what plagiarism is, and therefore plagiarize unwittingly or unintentionally. But ignorance is not an excuse for unethical academic conduct. To combat such ignorance, here are rules and resources to help you avoid any problems with plagiarism. Of course, these rules apply regardless of the citation form or style you may be using. Any instances of plagiarism will result in a zero on the assignment, and other sanctions as appropriate.

- a. Direct Quotations Whenever you directly quote someone else, you must provide a citation to the source of the material from which you are quoting. Moreover, you must put the material in quotation marks or otherwise set it off in an indented quote so the reader knows what words are yours and what words are quoted. It is unacceptable to use the words of others and only partially quote the original source. This is true even if you provide citation to the source both in text and in your references section!
- b. Paraphrasing/Indirect Quotations Whenever you indirectly quote someone else (i.e., you paraphrase the work of another), you must provide a citation to the source of the material from which you are paraphrasing. Simply changing the structure of a sentence, or a few words in a sentence so that the sentence you write is not an exact quote from the original source does not mean a citation is not needed. This is because the idea you are expressing is not your own, but rather someone else's.
- c. Using Other's Ideas Even if you compose an entire paragraph of writing in your own words (i.e., neither quoted nor paraphrased), if the idea you are expressing in that paragraph is not your own, original idea, you must provide a citation to the source from which you obtained this idea.
- d. Collaborative Work If you collaborate on any work with someone else and fail to acknowledge that collaboration, you are guilty of plagiarism. If you have received permission from you professor to collaborate on some assignment, be sure that all of the contributor's names appear on the submission.
- e. Altering or Revising Another's Work If you alter or revise the work done by someone and submit that work as your own, you have plagiarized. Similarly, if you allow someone else to alter or revise work that you have done and then allow that person to submit it as his or her own work, you are both guilty of plagiarism. Work that is not entirely your own must be credited by citation, both in text and in your references page.
- f. Altering or Revising Your Own Prior Work You should also be aware that altering or revising your own work that was prepared for another class or another professor, and not bringing it to the attention of the professor to whom you are submitting the revised work is also academic dishonesty. If, for example, you have two classes that require a

term paper, and you can write one paper that meets the requirements of both classes, you may not submit that paper to both professors unless you get permission to do so in advance from both professors. Similarly, if you wrote a paper several semesters ago that can be revised and submitted in satisfaction of a paper requirement for a course in which you are currently enrolled, doing so is academic dishonesty unless you get the advanced permission of your professor to do so. The reason this is dishonest is that it is not an original work prepared in satisfaction for the requirements on the course you are currently taking.

SYLLABUS CHANGE POLICY:

It will and can change based on the instructors' judgment or the evaluation of the class progress throughout the semester.
