**Catalog Course Description:** This course examines file and database organization techniques including SQL and NOSQL data models, commercially available and open-source database systems, database design and implementation, query language, transaction processing, database administration and database security.

Course Objectives: The objective of the course is to provide a basic understanding of the concepts, principles, and techniques of file and database organisation and how to apply them in the context of the design and implementation of a database application.

**Prerequisites:** Students who do not meet the pre-requisites must contact the instructor immediately.

### **Student Learning Outcomes:**

After successful completion of this course, students will be able to:

- 1. demonstrate understanding of the concepts, principles, and techniques of file and database organization
- 2. design and implementation of database application
- 3. understand the transaction processing, database administration and database security. Be able to design effective database schemas for realistic applications

# **Required Materials:**

- 1. **Textbook:** Database Systems Concepts, 7<sup>th</sup> Edition, by Silberschatz/Korth., ISBN: 978-0073523323. This book is a custom e-book available as an e-book and the cost of the e-book is included in tuition and fees. The e-book is available in Blackboard.
- Blackboard: Connect to <a href="http://tamusa.blackboard.com">http://tamusa.blackboard.com</a>. You will have lecture notes and other supplementary materials in Blackboard. All class communications will be through Blackboard and students should monitor this several times a day.
- Computer Hardware: In order to participate in the tutoring sessions you will need a computer with an internet connection, a microphone and speakers/headphones.
- **Time:** You are expected to spend 4-8 hours per week for the course. Based on the background, some student may require more time. Time spent may be longer when assignment/exams are due.

**Other Recommended** / **Reading Materials:** Additional reading materials are available on the course website as recommended by the instructor.

## Course Requirements every student must fulfill in order to succeed in course:

- 1. Students should check the Course Calendar, Announcements, and Messages (e-mail) systems in Blackboard on a regular basis.
- 2. Students should keep current with all course assignments and examinations.
- 3. If the course uses remote proctoring for exams, students must schedule their exam early in the semester.

**Grading Policy:** The final course grade will be based on your performance on the exams, assignments and class participation using the following weights:

The final letter grades will be assigned as follows: Above 90% A; 80 - 89% B; 70 - 79% C; 60 - 69% D; Below 60% F.

This course has a requirement of a grade of C as a minimal grade for satisfactory completion of the course.

**Examinations:** There will be mandatory Mid-term Exam and a mandatory Final Exam (as per university schedule). Being absent for an exam will result in a grade of zero for that exam and may result in a fail grade in the course. The exams will consist of conceptual problem-solving questions, and short essay

questions. The exam materials will come from lecture notes, the text, and class discussions. Questions will emphasize understanding and applications of concepts and topics covered in class.

**Assignments:** There will be several assignments during the course. For all assignments, ALL intermediate work of the problem solution steps MUST be shown. This includes the use of the formula, the values substituted in the formulas for problem solution, as well as the intermediate steps of the arithmetic computation. The units of measurement are extremely important and MUST be shown at each stage of the computation. Considerable points will be taken off for not following these requirements. All assignments will have a clearly indicated due date.

## Make up and Late Assignment/Exam policy:

All assignments will have a clearly indicated due date. Late assignments will be penalized 10% per day. As a general rule, no make-ups will be accepted for any missed assignments/exams. Make-ups may be accepted/administered only in extra-ordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation either before or within a few days of the missed assignments/exams.

Class conduct and civility code: Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions in class and online, including the following:

Class attendance and Participation: A vital part of every student's education is regular attendance of class meetings. Any absences tend to lower the quality of a student's work, and frequent or persistent absences may result in a failing grade. Students are responsible for the materials covered in class. The

course covers a lot of material and most students find at least some parts of it difficult. Class participation is highly encouraged as it makes the class more interesting and enhances the learning experience. Students are strongly encouraged to ask questions and participate in class discussions and problem solving. Good attendance and participation will be rewarded when final grades are assigned.

The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.
