Course Description: This course provides hands-on laboratory experiences that highlight the fundamental molecular, cellular, and genetic principles characterizing living organisms. The scientific method in the discovery of these principles will be the primary focus of the hands-on activities. This course is designed for students majoring in science fields and is a co-requisite for students taking BIOL 1306.

Learning Outcomes: By the end of this course students should be able to think and develop rationale for designing scientific experiments, perform experiments, data recording and reporting. In addition, they will learn how to efficiently communicate science to audience.

Course Content (Total points: 100)

Attendance (30 points)

- I will take attendance every day. 10- minutes late in lab will be considered. After that you will be early for next day, as you will miss your attendance for that day.

Teamwork (5 points)

- Teamwork is the basic requirement in the field of science. Work in teams towards accomplishment of your experiments. If one team member fails to perform their responsibility, the entire team loses this point.

Lab report (35 points)

- Lab reports will be due two times during course of the lab.

Journal article presentation (30 points)

- Each group will identify a research article related to the topics of cell biology, prepare and will give a 15 mins presentation followed by question and answer from the audience. Each member of the group will be graded individually based on their ability to present the journal article and critical thinking while answering questions from the audience.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
