## Course Description

Study of a specific topic in the art of writing and/or in the teaching of that art. May be repeated when a different topic is scheduled.

## Section Description

This course will explore linguistic justice both as a political orientation to language and literacy education and as a pedagogical and administrative practice. We will use the frameworks we develop this semester to interrogate our teaching philosophies and practices and to identify specific strategies for enacting linguistic justice at the level of the writing classroom, the writing center, and the writing program.

## Course Goals

As a group, we have identified six course goals we will work together to achieve this semester:

1. expand our knowledge of linguistic justice, including its related theories and terminologies;
2. assess and identify the effects of linguistic *in*justice;
3. develop a better understanding of and familiarity with justice-oriented pedagogies;
4. identify strategies for implementing linguistic justice in specific career fields;
5. improve rhetorical awareness and ability; and
6. learn to be vulnerable and active listeners.

## Course Requirements

To achieve these goals, we have agreed to work on a semester-long project that will entail the following components:

1. a proposal,
2. an annotated bibliography,
3. a draft,
4. a revision,
5. a "remediation,"
6. a presentation, and
7. a final revision.

In addition to the semester project, we will complete low-stakes writing exercises and workshops in class, where we will also engage in in-depth discussions of our readings based on the three questions you all will submit each week. Our in-class work will take the place of written reader responses such as discussion boards and reflections and will be crucial to our ability to achieve course goals. Attendance in class is, therefore, mandatory.

## Course Materials

We will read two books this semester:

1. *Linguistic Justice: Black Language, Literacy, Identity, and Pedagogy* by April Baker-Bell
2. *Linguistic Justice on Campus: Pedagogy and Advocacy for Multilingual Students*, edited by Brooke R. Schreiber, Eunjeong Lee, Jennifer T. Johnson, and Norah Fahim

Please make sure you have a copy of Baker-Bell's book by Week 2, and please make sure you have a copy of Schreiber et. al's book by Week 6.

In addition to the two books, we'll occasionally read texts related to linguistic justice that include, but are not limited to, scholarly articles, statements from professional organizations, language policies, sample syllabi, etc. I'll make these readings available through Blackboard.

## Grading

As we agreed, I will assess and grade your work this semester using a points-based labor-based grading system. Please see our grading contract for more information about this system and how I will use it.

## Use of Generative Artificial Intelligence (GAI)

I expect you to generate your own content this semester. However, there are situations and contexts within this course where you may use generative artificial intelligence (GAI) tools to support your work as a writer. For example, GAI technologies such as ChatGPT can work well as a starting point for written assignments, assisting you with brainstorming, outlining, generating ideas, and collecting basic information about a topic/idea. Note that the emphasis here is on "support." GAI programs have been shown to provide biased information, to circulate misinformation, to reaffirm Standard Language Ideology, and to generate writing that is minimally effective. For these reasons, I discourage you from using GAI technology to generate content **for you**. If you have reason to use GAI to generate content **with you**, then I ask that you consult with me before doing so. If I approve your use, you should acknowledge the GAI program you have used, and you should identify which portions of the text you submit were produced by GAI, if any. Using GAI content without my permission and/or without proper attribution qualifies as plagiarism.

As you all well know, being a graduate student is hard: You're taking a range of different classes that are asking you to complete a lot of work, often at the same time. 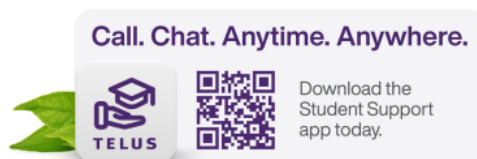

## University Policies

Please review the following for information on the university policies we will have to follow this semester:

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Religious Observances: Texas A&M University-San Antonio recognizes the diversity of faiths represented among the campus community and protects the rights of students, faculty, and staff to observe religious holidays according to their tradition. Under the policy, students are provided with an opportunity to make up any examination, study, or course work requirements that may be missed due to a religious observance provided they notify their instructors before the end of the second week of classes for regular session classes.

The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

#### *Students' Rights*
