Course Description: This course provides an in-depth exploration of the physiological responses and adaptations to acute and chronic exercise, with an emphasis on mechanisms underlying energy metabolism, neuromuscular function, cardiovascular and respiratory dynamics, and endocrine regulation. Students will examine how these systems interact during exercise and how they adapt with training across various populations. Emphasis is placed on developing the ability to interpret scientific literature and apply theoretical knowledge to practical and research contexts.

Course Objective: Upon completion of this course, each student will be able to:

1. Explain the physiological mechanisms underlying acute responses and chronic adaptations to aerobic and resistance exercise.
2. Analyze and interpret scientific literature related to cardiovascular, respiratory, neuromuscular, and metabolic aspects of exercise.
3. Apply evidence-based guidelines to develop exercise recommendations for healthy individuals and special populations.
4. Evaluate the impact of various training modalities on human performance and health outcomes.
5. Understand how various environmental conditions such as heat, cold, altitude, and humidity, affect physiological function and exercise performance.

Assignments: All assignments (e.g., lab report, presentation, mid & final exams, etc.) are due at set specific times throughout the semester. Details of each assignment will be provided in class.

Of note, late assignments will not be accepted (i.e., 0 point).

Extra Points: If you participate in research (and submit the evidence of participation) from the Kinesiology program, extra points will be added to your final points for the grade.

Academic Dishonesty: Students are expected to do their own course work. Academic dishonesty (e.g., cheating, plagiarism, fabrication, lying, bribery, threat, etc.) is a violation of the Student Code of Conduct; therefore, the instructor will report any form of academic dishonesty to the Office of Student Rights and Responsibilities.

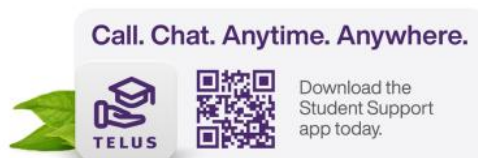

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

The university will provide such reasonable accommodations to pregnant students as would be provided to a student with a temporary medical condition that are related to the health and safety of the student and the student's unborn child. Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. Students' Rights

No Use of Generative AI Permitted
